
Sir,

2. The village-wise break-up of forest land at item no. B.2.3 in Form- A (Part-I) has been correctly uploaded in online portal and confirmed.







In compliance of the Ministry of Environment and Forests (MoEF), Government of India's Letter No. 11-9/989-FC(pt.) dated 3<sup>rd</sup> August 2009 wherein the MoEF issued guidelines on submission of evidences for having initiated and completed the process of settlement of rights under the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006(FRA short) on the forest land proposed to be diverted for non-forest purposes read with MoEF's letter dated 5<sup>th</sup> February 2013 wherein MoEF issued certain relaxation in respect of linear projects, it is certified that **2.892** hectares of forest Land proposed to be diverted in favour of the **Executive Engineer, National Highway Division, Jeypore**, for widening to two lane carriage way from 327/700 Km to 413/700Km of N.H – 326 under Vijayawada – Ranchi corridor in Koraput District falls within jurisdiction of **Dasmanthpur RL and Dharamgarh RL in Block /Tahasil : Boipariguda, Dist. Koraput.**

It is further certified that:

1. The complete process for identification and settlement of rights under the FRA has been carried out for the entire **2.892** hectares of forest area proposed for diversion. A copy of records of all consultations and meetings of the Gram Sabha(s) and the District Level Committee are enclosed as annexure **A**
2. The diversion of forest land for facilities managed by the Government as required under section 3(2) of the FRA have been completed and the Grama Sabhas have given their consent to it;
3. The proposal does not involve recognised rights of Primitive Tribal Groups and Pre-agriculture communities.
