(i)	Short narrative of the proposal and project/ scheme for which the forest land is required.	<p>Diversion of 0.8819 ha of Forest Land in Gurramguda RF of Amangal Division of Rangareddy District for formation of approach road from Nagarjunasagar main road to reach the Vipasyana Meditation Centre and Other Residential Dwellings situated in Sy.Nos.149,150,151,152,153,154,155,156 and 158 159 179 198 199 of Saheb Nagar (V) of Hayathnagar (M) of Rangareddy District through Gurramguda RF in favour of Sri B.Satya Prakash Rao and Others, Hyderabad.</p> <p>We have Vipasyana Meditation Centre and also having residential dwellings in Saheb Nagar Village, which is adjoining to the RF. We are using the existing cart track along the Reserve Forest to reach out the Vipasyana Meditation Centre and Other Residential Dwellings to carry out day to day work. The existing track is in use from our ancestral days.</p> <p>All of a sudden, recently Forest Dept officials have obstructed us for using the said road, claiming the said portion of land as forest land. As there is no other option for us to reach the Vipasyana Meditation Centre and Other Residential Dwellings and in order to avoid any legal complications, we are proposing for diversion of the existing road in my favour.</p> <p>We have explored the entire alternatives for formation of road through revenue and non-forest land &amp; we do not have any alternative approach road to reach the Vipasyana Meditation Centre and Other Residential Dwellings, except for formation of road passing through Forest Area, which was in use for many decades.</p> <p>Forest Land to an extent of 0.8819 ha is only required for formation of road.</p>
