	Mention date of grant of EC	Date of grant of EC is 15.02.2013 and which is later amended on 15.06.2018. The same detail has been updated in Part H (d) of Form A and also a copy of EC has been uploaded. Date of issuance of EC is appearing as NIL in Form A. To resolve this issue, NIC has been contacted several times and they have assured to rectify from Back End. Copy of Mail sent to NIC has been enclosed as Annexure-I .

	Mention whether CPSU	Bharat Coking Coal Limited (BCCL) is a Central Public Sector Undertaking (CPSU) under Ministry of Coal. Details of legal Status has been updated as CPSU in Part A-2 (Details of User Agency). It is not required to provide Non-Forest and Revenue Land for Compensatory Afforestation (CA) as user agency is CPSU. As Legal status of User Agency is CPSU, filling of details in Part L (iii) automatically disabled in Form A.

This is for your kind information that Bharat Coking Coal Limited has submitted a proposal for Forest Clearance vide proposal no. **FP/JH/MIN/32906/2018** named Kuya Colliery (OCP) on 02.04.2018.

In the proposal, a query has been raised regarding date of Environment Clearance on 23.04.2018 and the reply has been submitted on 08.05.2018 mentioning the date of EC and also the date of EC is resubmitted in Form A in point H (d).

Again query has been raised on 28.05.2018 regarding date of grant of EC the reply submitted on 03.08.2018 mentioning the date of EC. Again the date of EC has also been resubmitted in Form A in point H (d). However the date of EC is not being shown in Form A in spite of insertion of date in Form A in point H (d).

However on 30.08.2018 again a query has been raised regarding the date of grant of EC as it is not being reflected in point H(d) . In the Edit mode of application, the date of EC is being shown from initial date of application but is not showing in report generated of Form A leading to this problem and delay in Forest Clearance




