In exercise of the power vested in me vide FC-cum-Secretary (Fin) HP. Govt. Notification NO. Fin (6)(A) (3)-25/75 dated 30.7.96; the Administrative approval and expenditure sanction is hereby accorded for the aforesaid work amounting to Rs. 43,05,000 /- (Rupees Forty three lac five thousand) only.

Expenditure on this account will be debitabale under Head of Account: 5057-01 on Roads & Bridges, 04-District and other Roads, 337-Roads works, 02-Construction of Rural Road, 37 Major works (SOON) (Plan) and shall be restricted to the actual budget provision made during the current financial year (2003-2004).

The A/A&E/S is being accorded in view of necessity/importance of the work which is appearing in the schedule of New Expenditure (Plan) for 2003-2004 vide page CCNO. 34664 with a budget provision of Rs. 1.00 lac only. In view of budget assurance 2003-99 on the floor of House, new roads to be constructed only if communities give land free of cost, work to start only after the land is transferred to the Govt.
