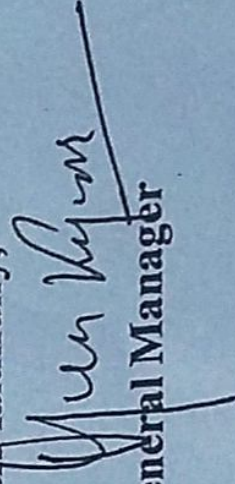
Sir,

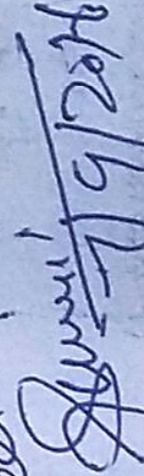
