## **Justification for the construction of LINGTI 0.5MW SHEP, located in Mohal Rakh, Tehsil Palampur, distt Kangra, Himachal Pradesh. Locating & diversion of 1.1163Ha forest land for the same.**

For the Lingti 0.5MW SHEP project, located in Village Rakh, Tehsil Palampur, distt Kangra of the state of Himachal Pradesh, our small hydro project as mentioned above, requires approx. 1.1163ha of forest area for construction of this project and the various project components. These included area for the construction of the,

- Diversion area and Intake on the Lingti khad & the desilting tank.
- Water conductor pipe / channel - penstock, as required and necessary, including tail race.
- Muck dumping sites & support structure.
- Powerhouse & Switch Yard area.
- Transmission Line from the powerhouse to the interconnection point, as specified, confirmed and approved by HPPTCL & HPSEB. Necessary approvals and confirmation has been taken by us from HPPTCL, Shimla.
- Bare minimum approach road to the powerhouse.

Catchment area of the Lingti nallah, is located below and above the diversion structure comprises of forest land, with minimum or no trees. The bed slope of the nallah, is in ideal condition for the hydro electric power generation from this project.

The natural flow of water and the regime of the nallah will not be disturbed and the water after electric generation, would be released back in the nallah on the run of the river principle, thereby conserving the water flow.

### **This 0.5MW SHEP Lingti project has many socio-economic benefits for the local population and the state of Himachal Pradesh, enumeration below**

- Generation and transmission of green / clean energy on long term basis, thru renewable energy sources, like water which is perennial and available round the year, by way of melting of snow and rainfall.
