## UNDERTAKING

This is with reference to the point no. vii raised in the MoEF letter ref.no. FC-II/CH -115/2019-NGP/5609 dtd. 14.08.2019, we undertake here with that we have done deep survey for our 8 MW SHEP Project to avoid forest land, which have resulted that only 2 hect. Forest land & 4.69 hect. Revenue forest land total 6.69 hect. had been identified.. However we made our best efforts to reduce the forest land for the project.

Since the project location was identified by the CREDA -nodal agency of C.G. Govt. according to the project feasibility & it is the RoR project, we was the limited options due to head /height of water fall for feasibility of the project. However we have checked with other 2 alternatives, in 1<sup>st</sup> alternative - was creating more than 10 hect. Of forest land (RF/PF) and was not found proper head for water fall, and in 2<sup>nd</sup> alternative around 8 hec. Forest land identified and high nos. of trees were found which requires heavy civil work in the forest area to meet our requirement.

Hence we have finalised the 3<sup>rd</sup> alternative which was required minimum trees with 2 hect. Forest land & 4.69 revenue forest land total 6.69 hect. Forest land & it meets our water head /fall requirement for the feasibility of the project.
