Dear Sir,

This is w.r.t. above mentioned subject and references, we hereby furnishing point wise clarification to the observations for your ready reference.

Point No. 1:

You had been informed to mark the distance between nearest sanctuary and the proposed project and between Eco Sensitive Zone and proposed project, Longitude and Latitude and the demanded forest land in tabular form on the Toposheet in 1:50000 scale attached to the proposal. But the Toposheet submitted along with the corrected proposal is not in original scale. As well as the area of nearest Karnala Bird Sanctuary and Eco Sensitive Zone and the required forest land area in tabular form have not been properly indicated on the Toposheet. Index has not been given in that proposal, hence you are requested to fulfil the required information.

Map showing distance of nearest Sanctuary (*Karnala Bird Sanctuary*) and Eco-sensitive Zone from proposed project area with geo-coordinates and demanded forest area in tabular form with Index mentioned in *1:50000 scale Toposheet* is enclosed as **Attachment – 2.**

Point No. 2:

In the submitted proposal there is no similarity in the area according to the plan in the village map and the area expressed in the table. Demanded area has to be indicated according to original scale of village map.

Proposed project area superimposed on visible and clear village map of Shahapur and Shahabad in original scale is enclosed as **Attachment – 3.**

Point No. 3:

In this proposal your demanding area is in the 50 meter buffer zone from the Kandalawan. In this regard it is necessary to indicate the proposed activities in the buffer zone.

Proposed 'Conveyor Corridor and Approach Road' crossing over 50m buffer zone of 'Kadalvan' i.e. Mangrove Reserved Forest (CRZ-IA) is 3757m². The demand area within 50 meter buffer zone of Kadalvan (Mangrove Reserve Forest) is 3757 m² which will be used for proposed project activities i.e. Conveyor Corridor and Approach Road. **Attachment - 4.**

Point No. 4:

Project executives did not submit the 7/2 extracts of the demanded area. Those have to be submitted.

Form 7/12 of affected area i.e. Survey No. 333, 334, 335A, 335B, 335K, 336, 338, 339, 340, 341, 342, 343 & 344 (Non Forest Pvt. Revenue Land) and Survey No. 346 (Govt. Land - Notified as Reserved Forest) of Village Shahbaz, Taluka Alibag, District Raigad (Maharashtra) falling under proposed 'Conveyor Corridor and Approach Road' is enclosed as **Attachment - 5.**

Form 7/12 of Forest Area falling under Survey No. 1002 of Village Shahbaz and Survey no. 600 and 602 of Village Shahpur, Taluka Alibag, District Raigad (Maharashtra) through which proposed 'Conveyor Corridor and Approach Road' is yet to be prepared by revenue department.

ACL has applied vide letter no. ACL/ENV/Forest/Maha/05-19/05 dated 12th June, 2019 to prepare Form 7/12 at Office of Tehsildar, Alibag (Copy Enclosed as **Attachment 6**). It is pending with Tehsildar office.

Notification No. RB/Desk-II/Forest/CR. 2372/2013 dated 20th August, 2015 issued by the office of the Divisional Commissioner, Konkan Division is attached as **Attachment 7** which show Legal status of demanded area as "Reserved Forest".

Point No. 5:

Submit the CD of KML File again with the proper indication of the demanded area.

CD containing KML File of proposed project area enclosed as **Attachment - 8**

Point No. 6:

It is necessary to indicate accurately the legal status of the demanded area of forest land marked on the village map.

Demanded area for diversion of forest land (0.6497 ha) is a Reserved Forest under section 4 of Indian Forest Act, 1927. It is notified vide RB/Desk-II/Forest/CR. 2372/2013 dated 20th August, 2015. (Copy of Notification enclosed as **Attachment - 7.**

Point No. 7:

Which way or road will be used to transport the material for the development in the proposed area demanded by project executor? The way and other way should be marked on the village map and it is necessary to explain the legal status of the ways.

Material transportation for development work in the proposed area will be brought through creek. The proposed approach road will connect to existing road constructed by



Zilla Parishad which ultimately connect to National Highway – 166A. Map showing proposed approach road to the local road is given **Attachment – 9**.

Point No. 8:

Details of the conveyer belt which is demanded for the development of the project have to be included in the proposal i.e.

- a. Survey nos., area and the name of the village*
- b. Legal status of the land*
- c. Copies of the 7/12 extract of the respective land*

Details of Survey nos., Area, Name of Villages & legal status of land demanded for proposed project is shown in map (**Attachment – 3**). Copies of 7/12 extract and relevant notification is given in **Attachment – 5** (7/12 Copy), **Attachment – 6** (Request Letter to Tehsildar Office) & **Attachment –7** (Government Notification).

Point No. 9:

Certificate of collector in Performa given in the forest act 2006 has to be submitted along with the proposal.

Application for NOC under The Schedule Tribe and Other Traditional Forest Dwellers (Recognition of Forest Right) Act 2006 for forest land admeasuring 0,6497Ha for 'Berthing Jetty, Conveyor Corridor with Backup Facility and Approach Road' has been submitted to the office of District Collector, Raigad. Copy of acknowledgment enclosed as **Attachment – 10**.

Point No. 10:

Sanction letter of a person who is signing authority of proposal has to be included in proposal. Signature, Name and Post of signing authority has to be given along with the stamp wherever necessary in the proposal.

Copy of Board Resolution authorizing representatives for signing the proposal is attached as **Attachment – 11**.

Checklist is enclosed as **Attachment – 1** for your kind perusal.
