1	Vide this office EDS dated 04-04-2016 & 23-05-2016, it was requested to provide point wise reply to 5 points raised in this office EDS dated 21-02-2016. However, in the online reply of State Govt dated 26-05-2016, reply to only points 1, 2 & 3 has been submitted and reply to point 4 and 5 is still awaited.	Point No. 1- Short narrative of project is given online in A-1-(iii)  Point No. 2- Map once again uploaded in online in C (iii) & (iv)  Point No. 3 - Total area required for diversion of land is civil and area of site selected for muck dumping is included in total area required for diversion for road construction.  Point No. 4 - Related to DFO (The State Govt may review the density and NPV calculation and submit revised calculation.)  Point No. 5 - Related to DFO (The Date of site Inspection by DFO is wrongly filled in Part-II, need to be rectify.)
2	In reply to Point 1 it is mentioned that short narrative is uploaded at Part 1 A 3 but same narrative has been referred in the reply without making any addition in response to observation of this office. Since this narrative has been already been found insufficient, it is once again requested to provided proper short narrative including information on all important aspects of the project. In reply to point 2 it is mentioned that geo referenced map is re-GIS software New map uploaded in C uploaded at Part I C. However, perusal of the shows that it is (iv) with coordinates at a interval 200 still on google earth image which does not serve any purpose. to 300 m The State Govt was requested earlier also vide EDs dated 21.02-2016 & 04-05-2016 to provide GIS Software generated digital map. However, time and again State Govt is forwarding the same google earth map, which is not understood. It is once again requested to provide/upload scanned Copy of GIS Software generated geo referenced digital map showing geo coordinates at 200 to 300 m interval along the alignment of the proposed road including all turning points (TIFF, IMG or JPEG) Inreply to point No. 3 it is mentioned that the total area required Muck dumping area is included in for diversion is civil land and include muck dumping also. Civil and which is shown in B2.4 part However in the muck disposal plan provided in the hard copy no I online. Geo reference map is objection certificate of some private individuals for muck uploaded in C (iv) dumping on their land have also been attached, which needs to be explained. In case the civil land required for muck dumping sites has been included in the area proposed for diversion, it may be explained why the extent of civil land proposed for muck dumping has been shown separately in the component wise breakup at B2.4 Part I online. This may be done now and

locations of the dumping sites along with geo coordinates may also be shown on the geo referenced digital map to be provided




