It is further intimated that damage report for breaking of Govt. land was imposed to contractor vide report book No. 09/KL2015-16 report No. 93 dated 21/4/2023 for Rs. 6900/- only (Six thousand nine hundred) only which was paid in cash by the contractor (Photo copy of damaged report attached).

It is submitted that the source of the scheme is Satluj River at right bank near Village Kut Bounger in GP Koserian Tehsil Jhandutta Distt. Bilaspur (H.P.). The NOC for lifting of 8.00 MLD water has been obtained from BBMB authorities vide their letter No. 8380/B-800/DHD dated 5/12/2018. Accordingly the A/A & E/S of this scheme has been accorded by Secretary Govt. of H.P. vide No. Secy.-IPH-B(F)5-13/2018 dated 22/10/2019 for Rs. 3781.45 lacs only as well as the Technical Sanction has also been accorded by the Engineer-in-Chief vide his office letter No. IPH-CTR-29-2-1036/LWSS Govind Sagar Lake/2019 – 4117-22 dated 14-01-2020 for Rs. 3260.02 lac only.

The work of this scheme has been awarded to the M/S R.G. Industries vide this office letter No. JSV-JSVDJ-E-tender award/2020-21-2919-29 dated 25/8/2020 amounting to Rs. 30,42,06,484/- only after completing the all codal formalities. Earlier the FCA case for diversion of 1.3463 hectare of forest land in favour of Jal Shakti Vibhag has been submitted to your good office on dated 09-01-2021, but same has been received back many times with some observations raised by your department vide letter No. Ft. 48-5049/2020(FCA) - dated 17-06-2023.
