Further as per GOI Requirements, the detail of alternate alignments if examined and the muck dumping sites are also required to shown on KML file.	The compliance of the objection has been done and uploaded in online portal. 2.	Against column C(iii) &(iv) the toposheet and digital map of the proposed area has not been found uploaded, but the same have not been signed by the user agency under office seal. 3.	Against column No.D(ii), 'No' has been mentioned and against column No.D(ii)a. Reason for not providing such map: CENTRAL GOVT. PROJECT, has been mentioned. If the alternate alignment has not been examined, the reason for not examine the alternate alignment is required to be mentioned against this column	The undertaking is issued from Executive Engineer, ICBRPD-III, CPWD mentioning that no alternate alignment is suitable and also uploaded in portal. Also it is to consider that the case pertains to defence roads and approved alignment from IG(ops), ITBP directorate, New Delhi and uploaded in additional information details.
4.	Employment details against column No.E(ii) 20 and against column No.E(iii) 80 has been mentioned . Employment details whether it is temporary or regular are requirement to be mentioned . It is required to be clarified by the user agency whether only 80 temporary employments will be generated from the construction of said road. 5.	Against column No.1(i), 'No' has been mentioned. As per latest instructions of GOI, In case of 'NO', the distance from the protected area or their Eco Sensitive Zone is required to be obtained from DFO concerned for uploading against additional information detail.
