With reference to the above, I have the honour to furnish below the essential details sought vide the queries under reference for the application of forest land diversion proposal for the work 'Improvement and upgradation of Gohpur Dholpur Road via Ghagrabasti Road [Ghagrabasti to Mazgaon & Shantipur to Hollongi Chariali]'. The details are:

Please rectify the anomaly	Noted. The Memorandum of Agreement with Deputy Commissioner for acquiring land for compensatory land has been attached.
2	L-(v)	After careful examination of the uploaded map, it is found that the uploaded map is not a georeferenced map in large scale. Also, only two CA land pertaining to dag No. 31 and 32 is depicted in the map instead of showing all the other proposed CA land.	The same has been revised and revised map has been attached.
3	L-(v)	After careful examination of the uploaded map, it is found that the uploaded map is not a full scale SOI (1:50000 scale) toposheet map but is only a subset of. Also, only two CA land pertaining to dag No. 31 and 32 is depicted in the map instead of showing all the other proposed CA land.	The same has been revised. The revised map has been attached.

5	2	Please withdraw the old undertaking for NPV wherein the forest land to be diverted is mentioned as 43.47 Ha.	The same has been withdrawn.
6	3	Please upload the revenue map of the proposed CA land	The same has been uploaded.
7	4	Please upload the site suitability report of the concerned DFO for the proposed CA land.	The same has been uploaded.
8	5	Also, after careful examination of the KML files for the 9 no. of proposed CA land, it is found that only three CA land area are above 5 ha and the remaining 6 Nos. are below 6 Hectares.	The plots of smaller sizes have been discarded and new plots adjacent to each other having combined area larger than 5 Hectares have been considered for compensatory plantation/ afforestation.
