i)	Short narrative of the proposals and project scheme for which the forest land is required.	:	<p>Diversion of <b>0.9717 Ha</b> (previously <b>0.567 Ha</b>) forest land all the periphery of Tumulur RF of Shamshabad Division for construction of approach road to reach the agricultural and farm lands from Srisailem Highway to Lemoor Village in favour of Tumfor Agrifarms LLP, Shaikpet Nala, Hyderabad.</p> <p>We have initially proposed for diversion of 0.567 Ha in Tumulur RF for formation of road over a length of 945.06 M in length and 6.0 M in width. Duly processed proposals with due recommendations of Forest Department was submitted to the IRO, MoEF&amp;CC, GoI, Hyderabad vide State Government Lr.No.3449/For.I(1)/2020, dt.01.01.2021, alongwith RoFR certificate obtained from the District Collector.</p> <p>The IRO, MoEF&amp;CC, GoI, Hyderabad vide Lr.No.4-TSB178/2021-HYD/357, dt.05.04.2021 has called for certain additional information. Point (b) of the said letter is to examine the alternative roads to avoid forest area diversion, as the proposed road will bifurcate the RF block.</p> <p>The said issue was examined by the Forest Department and the PCCF &amp; HoFF, TS, Hyderabad vide Lr.No.5976/2019/FCA1,d t.06.11.2021 has requested us to submit DGPS data for diversion of forest land for formation of road all along the periphery of the Reserve Forest, as the existing road which is proposed for diversion earlier by us (sent to GOI with recommendations), was closed by Forest Department duly forming a trench, as such we are proposing the alternative formation of road, as suggested by Forest Department.</p> <p>Accordingly, the said proposal is being submitted for formation of road, as it is required for the villagers of Lemoor Villages for carrying out day to day agriculture works.</p>

DGPS surveyed map duly authenticated by the Geomatics cell of Prl. Chief Conservator of Forests office vide PCCF Rc.No. <b>5976/2019/FCA1, Dated: 08.02.2020</b> is also enclosed.
iii)	Cost of the Project	:	Cost of the project will be around Rs.30.00 Lakhs including the cost to be paid towards Net Present Value and Cost constructions of boundary pillars and others, as demanded by Forest Department.
