The subject item mentioned below was discussed in the 134th Meeting of the Committee of Functional Directors (CoFD) of South Eastern Coalfields Limited held on 17.08.2022 vide Item No.134.01. The extract of the approved Minutes of Meeting are quoted below:

Item No. 134.01

Sub: Approval of Mining Plan for Jhiria West Opencast Project (1.50 MTY) of Hasdeo Area for obtaining Environmental Clearance from MOEF&CC.

Ref: GM (P&P)-HOD's e-Office Noting (e-784638) Dtd. 19.07.2022.

The Committee of Functional Directors (CoFD) discussed on the subject proposal and GM (P&P) apprised the CoFD that:

- The PR for Jhiria West Opencast Project (1.50 MTY) of Hasdeo Area was approved by SECL Board at its 279th meeting held on 28.11.2018 (Item No. 279:4:2) for Partial Outsourcing Option-II (Coal Departmental and OB Outsourcing), involving a capital investment of ₹389.97 Crore, for a project area of 482.694 Ha. to extract 14.35 MT of coal involving 115.33 M Cu.m. of OB removal having average stripping ratio of 8.4.
- Accordingly, Notification for acquisition of land for an area of 481.711 Ha. of Land u/s 4(i) of CBA (A&D) Act 1957 was issued on 12.08.2016. However, Hasdeo Area has noted that during the process of obtaining land records from State Government, there was mismatch in 53.718 Ha. land records between forestry & non-forestry land. As the 53.718 Ha. land falls within the 481.711 Ha. of land and is on extreme eastern part of quarry, this area was earmarked to be worked after the 4th year. Accordingly, 427.993 Ha. of land was notified u/s 11(i) on 18.05.2019.
- In view of the above, Hasdeo Area has submitted the subject modified Mining Plan for Jhiria West OCP (1.50 MTY) for 427.993 Ha. of land to extract 13.16 MT of coal by removing 107.95 M Cu.m. of OB having stripping ratio of 8.2, incorporating, modified stage plan, calendar programme and Mine Closure Plan.
- The modified Mining Plan as submitted by GM, Hasdeo Area further vetted by RD, CMPDIL, RI-V, Project & Planning, Environment/Forest, L&R and Finance Departments, SECL HQ and recommended the same for obtaining EC.

The CoFD noted the above appraisal and after detailed deliberations, approved the subject Mining Plan for Jhiria West OCP (1.50 MTY) of Hasdeo Area for obtaining Environmental Clearance (EC) from MoEF&CC, as detailed and brought out in the agenda.
