It has been intimated that an area of 7.143 Ha will be used as Safety zone however the kml file of 7.143 Ha Forest land for Safety Zone has not been uploaded on PARIVESH portal, which is required to be done. It is pertinent to mention here that the area of safety zone has been mentioned as 84.778 Ha in the Mine Plan/ Mine Closure Plan.
