A proposal has been received by this office from M/s. RM Delicious Foods for diversion (under FCA-1980) of 0.003 ha. of forest land for non-forestry purpose. The projects envisage the use of land on Israna-Seenk road (ODR), at km. 17.055 (RHS), Village Seenk, Tehsil Israna, Distt. Panipat.

1. The site inspection of the land involved in the proposal has been done on dated **19-08-2021**
2. On inspection of the site, it is found that the land required by the user agency is a Protected forest measuring **0.003** hectare to be utilized by user agency and there is no trees effected in **the acceleration lane & deceleration lane way of the factory**.
3. The requirement of forest land as proposed by user agency in Col.2 of part-I is unavoidable and is barest minimum required for the project. The detail of forest area and effected is as under:-


