Further as per discussion held with your representative, correction has been made accordingly and hereby submitted. Pointwise compliance of objection raised by MoEF is as below:-

2.	Geo referenced map uploaded at C-b(iv) in Part-I of the proposal is without geo coordinates of key points.	Geo referenced map with geo coordinates of key points has been uploaded on portal and hard copy of the same in 5sets is enclosed herewith. (Annexure-II)
3.	The project justification note uploaded with the proposal mentions requirement of forest land for retail outlet whereas the proposal is for 132KV transmission line for evacuation of power (in Part-I at D (i))	Modified document has been uploaded on portal and hard copy of the same in 5sets is enclosed herewith. (Annexure-III)
4.	Forest notification uploaded is a scanned copy of working plan which is not clear and does not provide the date of notification.	Fresh notification has been uploaded on portal and hard copy is already provided in hard copy with proposal.

5.	The proposal is without examining alternatives to arrive at minimum forest land requirement as per D(ii) of Part-I. Though in hard copy, three alternative have been submitted without providing forest area involved in each alternative and neither providing geo coordinates of key points.	Two alternative roots with coordinates of key points and forest area involved have been uploaded on portal and hard copy of the same in 5sets is enclosed herewith. (Annexure-IV)
6.	Part-II of the proposal submitted does not mention legal status of forest land proposed for diversion.	To be resolved from DFO level
7.	Compensatory Afforestation scheme is without cost escalation due to inflation	To be resolved from DFO level
8.	The proposal is without submission of mandatory afforestation of dwarf medicinal plants below transmission line	Hard copy of the estimate for mandatory afforestation of dwarf medicinal plants is enclosed in proposal. Soft copy of same is required to be uploaded in Part-II from DFO level
9.	The proposal is without two separate enumeration list duly providing details of trees affected and trees to be felled.	To be resolved from DFO level
10.	Xerox copies of FRA 2006 related documents/certificates have been submitted with the hardcopy of the proposal.	Only one original copy of FRA 2006 was available which had been enclosed in proposal sent to State Govt. Colored photocopies of the same in 5sets is enclosed herewith (Annexure-V)
11.	Joint inspection report has been uploaded as site inspection report as additional document in Part-II	To be resolved from DFO level
12.	The proposal is without details of number of towers proposed in forest land and non forest land	Details of number of towers proposed in forest and non forest land in 5sets is enclosed herewith (Annexure-VI)
13.	Correct Part-III has not been uploaded at Sr. No. 16 of Part-II	To be resolved from CCF level
