With reference to the queries raised your letter referred (i) & (iii) above, following are our point wise submissions -

(i)	Extant proposal is an offshoot of the approval already conveyed by the Central Government in the past. Therefore, proposal should be processed as an additional area of already approved proposal while the state government has processed the extant proposal as standalone project without linking it with the previous approval. Rationale for considering the extant project as standalone project may be furnished by the state.	The Stage-II approval for diversion of 97.2477 ha forest land for construction of North Karanpura Super Thermal Power Project of NTPC was accorded on 03.11.2015 . The same has already been attached in the present proposal. Subsequently, during construction phase it emerged that some patches of area 10.24 Ha of JJ land (5.79 Ha in Ash Pond + 4.45 Ha in Reservoir) falling within the proposed Plant boundary of NTPC was still notified with WRD, GoJh for Garhi Dam project. This JJ land of 10.24 Ha was not included in original proposal of 97.2477 ha forest land for which Stage-II approval is already accorded. NTPC then pursued with GoJh for transfer of this land to NTPC. Later, vide GoJh Rajyadesh no. 2437 dated 05.07.2019, 10.24 Ha of JJ land was transferred to NTPC. Subsequently, NTPC as User Agency has applied for Forest clearance of 10.24Ha JJ Land which is in patches and falling inside the proposed layout of Ash pond and Reservoir of North Karanpura Super Thermal Power Project of NTPC. (ii)	Justification submitted by the user agency for proposing forest land for the non-site specific activity is not convincing as no detail of alternative sites explored for setting up the reservoir and ash dyke has been made available in the extant proposal.	The proposed JJ land of 10.24 Ha (5.79 Ha in Ash Pond + 4.45 Ha in Reservoir) is encompassed by the originally approved land of Ash Dyke and Reservoir of North Karanpura Super Thermal Power Project of NTPC (Refer attached layout). The requirement of the land is integral part of both Ash Pond and Reservoir to ensure the design geometry and technical completeness. The proposal is therefore unavoidable and location specific.
`		Any alternative site beyond the approved plant boundary of thermal power plant shall not serve the desired purpose.
(iii)	Extant proposal is non-site specific which can be established on the non-forest land. Detail of efforts made by the State government to identify the non-forest land for the establishment of ash dyke supported with documentary evidence may be made available.	Since the proposal is unavoidable and location specific, any alternative land (either forest or non-forest), beyond the approved plant boundary of thermal power plant shall not serve the desired purpose.
(iv)	Detail of non-forest land nearest to the thermal power plant may be intimated by the state along with its current land use.	The proposed JJ land of 10.24 Ha is encompassed by the originally approved land of Ash Dyke and Reservoir of North Karanpura Super Thermal Power Project of NTPC. (Refer attached layout).
		The requirement of the land is integral part of both Ash Pond and Reservoir to ensure the design geometry and technical completeness. The proposal is therefore unavoidable and location specific.
		Any alternative land (either forest or non-forest) beyond the approved plant boundary of thermal power plant shall not serve the desired purpose.
(v)	As per details of ash pond area approved along with original proposal of the user agency, an area of 333 ha was proposed for ash pond including 46.86ha of forest land. Status of utilisation of area approved in the past for the indicated purpose needs to be intimated by the state.	The area of 46.86ha of forest land in ash pond approved in original proposal has been utilised completely for ash pond. (Marked in yellow in attached layout)
(vi)	Status of compliance of conditions stipulated in the approval dated 3.11.2015 granted for 97.2477 ha of forest land may be intimated by the state.	The Annual Self compliance report for conditions stipulated in the approval dated 3.11.2015 granted for 97.2477 ha of forest land has already been submitted to DFO(Chatra) office on 07.02.2022 vide NTPC letter Ref: 043/EMG/NK/Forest/dtd. 04.02.2022.

(vii) Proposal pertaining to Garhi Jalashay Yojana involving an area of 689.835 ha of forest land is still active in the Ministry. The state government may therefore, confirm the submission made by the user agency about the termination of Garhi Jalashay Scheme and also inform the status 689.835 ha of forest land proposed for Garhi Jalashay Yojana. Further, in case the state Government is not interested in the said project a request for closure of the said proposal may be submitted to the ministry.

There is no requirement of Garhi Jalashay Yojana for North Karanpura Super Thermal Power Project of NTPC. The same has already been intimated to WRD, GoJh in Feb 2015.

Sub: Diversion of 97.2477 ha (101.922 ha proposed originally) forest land for construction of North Karanpura Super Thermal Power Project in favour of NTPC in district Chatra in Jharkhand – regarding.

Sir,

I am directed to refer to the State Government of Jharkhand's letter no. Vanbhumi - 45 / 2007 / 3102 dated 27.06.2007 on the subject mentioned above seeking prior approval of the Central Government under Section-2 of the Forest (Conservation) Act, 1980. After careful consideration of the proposal by the Forest Advisory Committee constituted under Section-3 of the said Act, 'in-principle' approval was granted vide this Ministry's letter of even number dated 8.06.2009 read with letter dated 14.12.2009 subject to fulfillment of certain conditions prescribed therein. The State Government has furnished compliance report in respect of the conditions stipulated in the 'in-principle' approval for diversion of only 97.2477 ha as against 101.922 ha approved in-principle' approval as the said land is not required by the user agency. The State Government has also certified that no non-forest activity has been taken up on the said land of 4.6742 ha. The Ministry has examined the matter and accepted the request of the State Government to exclude the 4.6742 ha of forest land from the total forest area approved for the diversion and accordingly amended Stage-I approval for diversion of 97.2477 ha was issued by the Ministry vide its letter of even number dated 3.11.2015.

Further, in this connection, I am directed to say that on the basis of the compliance report furnished by the State Government vide letter no. *Vanbhumi*-45/2007/6002 VP dated 6.02.2014 and *Vanbhumi*-45/2007/3284/VP dated 23.06.2015, final approval of the Central Government is hereby granted under section-2 of the Forest (Conservation) Act, 1980 for diversion of 97.2477 ha (101.922 ha proposed originally) forest land for construction of North Karanpura Super Thermal Power Project in favour of NTPC in district Chatra in Jharkhand subject to fulfillment of the following conditions:

- 1. Legal status of the diverted forest land shall remain unchanged;
- Compensatory afforestation over degraded forest land, double in extent to the forest land being diverted, shall be raised by the State Forest Department from the funds already provided by the user agency;

- The project area shall be demarcated on ground at the project cost, using four feet high 3. RCC pillars, with each pillar inscribed with the serial number, forward and backward bearings and distance between two adjacent pillars.
- The User Agency shall ensure that ash disposal is carried out as per the detailed plan 4. prepared for the purpose, and is in accordance with all environmental safeguards.
- Wherever possible and technically feasible, the User Agency shall undertake by 5. involving local community, the afforestation measures in the blanks within the lease area, as well as along the roads outside the lease area diverted under this approval, in consultation with the State Forest Department at the project cost.
- The User Agency pay the additional NPV, if so determined, as per the final decision of 6. Hon'ble Supreme Court of India.
- The user agency should give an undertaking that it shall take all measures to prevent 7. pollution by effluents, particulate matters etc at the project cost.
- The user agency will develop a green belt along the power station and also along the 8. water pipe line/channel.
- No labour camp shall be established on the forest land; 9.
- The User Agency shall provide fuels preferably alternate fuels to the labourers and the 10. staff working at the site so as to avoid any damage and pressure on the nearby forest areas;
- The boundary of the diverted forest land, mining lease and safety zone, as applicable, 11. shall be demarcated on ground at the project cost, by erecting four feet high reinforced cement concrete pillars, each inscribed with its serial number, forward and back bearing and distance from pillar to pillar;
- The layout plan of the proposal shall not be changed without the prior approval of the 12. Central Government.
- The forest land shall not be used for any purpose other than that specified in the 13. proposal;
- The forest land proposed to be diverted shall under no circumstances be transferred to 14. any other agency, department or person without prior approval of the Central Government;
- No damage to the flora and fauna of the adjoining area shall be caused; 15.
- Any tree felling shall be done only when it is unavoidable and that too under strict 16. supervision of the State Forest Department;

- The user agency shall submit the annual self-compliance report in respect of the above 17. conditions to the State Government and to the concerned Regional Office of the Ministry regularly.
- Any other condition that the concerned Regional Office of this Ministry may stipulate. 18. from time to time, in the interest of conservation, protection and development of forests & wildlife; and
- The User Agency and the State Government shall ensure compliance to all conditions 19. of Stage-I approval for which undertakings have been obtained from the user agency and also provisions of the all Acts, Rules, Regulations and Guidelines, for the time being in force, as applicable to the project.

आदेश :- स्वीकृत।

- i. जिस प्रयोजन हेतु भूमि का हस्तांतरण किया जा रहा है, उसमें भूमि की आवश्यकता नहीं रहने अथवा पाँच वर्षों की अवधि तक भूमि का उपयोग नहीं किये जाने पर यह भूमि स्वतः राजस्व, निबंधन एवं भूमि सुधार विभाग को वापस हो जाएगी।
- ii. उपायुक्त, चतरा प्रस्तावित भूमि के हस्तांतरण से संबंधित सभी खातों एवं प्लॉटों में अंकित रकबा का खतियान एवं अन्य राजस्व कागजातों से सत्यापन एवं मिलान कर आश्वस्त होने के पश्चात् ही भूमि हस्तांतरण की कार्रवाई करेंगे।
- iii. यदि परियोजना के अंतर्गत वृक्षादि है तो वैसी स्थिति में वृक्षों की लागत मूल्य की गणना कर एकरारनामा के समय कंपनी से राशि प्राप्त कर ली जायेगी।
- iv. प्रस्तावित भूमि के हस्तांतरण की तिथि को भूमि के वर्तमान मूल्य के आधार पर सलामी एवं लगान तथा सेस की गणना कर अंतर की राशि प्राप्त कर संबंधित उपायुक्त द्वारा भूमि की लीज बंदोबस्ती की जायेगी। परन्तु प्रस्तावित भूमि के मूल्य से यदि कम होता है तो अनुमोदित राशि की ही वसूली कर भूमि की लीज बंदोबस्ती की जायेगी। किसी भी परिस्थिति में यह राशि अनुमोदित राशि से कम नहीं होगी। अगर परियोजना से संबंधित दर/सलामी, लगान एवं सेस सहित राशि में अंतर परिलक्षित होता है तो अंतर राशि को
