1.	The State Govt, will provide the distance of the proposed bus stand from existing bus stand.	Distance of proposed Bus Stand from existing bus stand is as under:- 1. Distance from Bus Stand Rampur to proposed Bus Stand Luhri is=33km. 2. Distance from Bus Stand Ani to proposed Bus Stand at Luhri is=20km. 3. Distance from Bus Stand Kumarsain to proposed Bus Stand at Luhri is=21km.
2	The State Govt, will provide technical note on traffic volume of proposed bus stand.	Almost 50numbers of buses will enter proposed bus stand Luhri everyday & 80 to 100numbers of private vehicles to drop & pick up the passengers will also enter at proposed Bus Stand. Luhri being a fastly growing town faces serious traffic congestion problems. The present scenario at the existing bus station at Luhri faces lack of basic amenities, traffic congestion problems, lack of proper parking facilities for passenger vehicles, improper parking of buses, lack of toilet facility, lack of waiting room facility etc. In order to overcome this situation, Bus Stand Luhri should be constructed in larger public interest.
3.	In reply of this office EDS letter dated 04.08.2021. Point no.3, the State Govt, has shown the road to the proposed bus stand in kml, but it is not clarified that this is part of diversion or is already existing road. Therefore, detail in this regard may be submitted.	Road shown in the KML to the proposed bus stand is the part of Diversion.
3	The State Govt. stated that after the completion of project, the dumping area will be used for ideal bus parking but the area of said activity is already been taken and no additional requirement is justified by the Govt. for the same. The State Govt. will provide separate enumeration of trees for the dumping area and also mention this area in component wise break-up. Further the dumping area will be handed over to the State Forest Department after reclamation as per plan at the cost of project by the User	Before starting the construction works of Bus Stand Luhri, a retaining wall is proposed in front of this and all the muck generated during the construction work of Bus Stand Luhri will be dumped behind this retaining Wall. Therefore, the Dumping area is the part of proposed bus stand and the enumeration list of trees coming in the Bus Stand alignment has already been submitted along with Proposal folders. Since, all the muck generated during the construction works will be dumped in the retaining wall hence, there is no need to handed over the dumping site to HP Forest Department.
