**Petroleum and Natural Gas Regulatory Board (PNGRB)**, a regulatory body set up by Govt. of India, for laying, building, operating and expending City Gas Distribution (CGD) has authorized BPCL to setup City and Local Gas Distribution (CGD) Network in Saharanpur Geographical Area in Uttar Pradesh. Copy of authorization is enclosed herewith as **Annexure-A**.

As per above authorization granted by PNGRB, BPCL propose to lay 200/150/125/90/63 mm dia Steel/MDPE natural gas pipeline in Saharanpur District and surrounding area. Proposed network will be originated from GAIL's existing station in village Dipakhedi and will set up CGD network through various spurries in whole Saharanpur district and surroundings. The proposed pipeline will be laid along/across the side strips of various roads, nalas, rivers, rail routes declares as protected forest. Pipeline will be laid at depth of 1.2 mtr. below the natural ground level. All precautions shall be followed as per PNGRB Guidelines and safety standards. Description of the area to be diverted by pipeline passing through the forest land in Saharanpur District in Uttar Pradesh is furnished in **Annexure-B** enclosed.
