FCA The Chief Engineer (R&B) LWE, RSW, D&P & RR, Hyderabad in the reference cited has informed that, the road work taken up by laying of black top (BT) road from Pangidi to Madhura Thanda from Km 0/0 to 9/859 via Chinnadoba, Peddadoba, Somuguda and Babjipet villages of Sirpur (U) Mandal of Jodeghat range in Chorpally Reserve Forest, falling in Compartment No.494, 493 of Babjipet Beat, 500 of Peddadhoba Beat & 492 of Kakar Buddi Beat of Sirpur (U) Section Sirpur (U) Mandal in the Forest Area to an extent of 2.981 Ha ie., Length of 3977.43 meters with a width of 7.50 meters, without taking prior permission from Government of India under the provisions of Forest (Conservation) Act, 1980

From the above it is observed that, the above two officers are failed to obtained prior permission from competent authority under the provisions of Forest (Conservation) Act, 1980 which clearly shows gross negligence towards duties & dereliction of duties and also violated Rule No. 3 (1) of T.S.C.S (Conduct) Rules, 1964, Section 2 of the Forest (Conservation) Act, 1980 and Wild Life (Protection) Act, 1972.

Hence, show cause notice issued to the above two officers to submit their explanation why disciplinary action shall not be initiated as per Conduct Rules 1964 for executing the above work in forest area without taking prior permission from competent authority under the provisions of Forest (Conservation) Act, 1980.

The explanation should reach within 10 (Ten) days of receipt of this Memo Positively otherwise further action will be initiated based on the records available in this office.
