

Shri Muktsar Sahib Virtual Pipeline – Diversion of 0.177 Hectare of Protected Forest land various Road side strip plantation declared as protected forest for laying of 8" dia Steel Natural Gas pipeline in Shri Muktsar Sahib District of Punjab State – Request for granting permission

## UNDERTAKING

1. [Clause No. 6.a] - Gujarat Gas Limited, hereby undertake that GGL has proposed to lay pipeline along/across the existing ROW of roads side strip plantation declared as Protected Forest without disturbing the standing trees. GGL is also undertake that no any trees will be cut or damaged during laying pipeline.
2. [Clause No. 6.b] - Gujarat Gas Limited, hereby undertake that GGL has proposed to lay pipeline along/across the existing ROW of roads and after completion of the project the area under ROW shall be reclaimed suitably.
3. [Clause No. 6.c] - Gujarat Gas Limited, hereby undertake that GGL has proposed to lay pipeline along/across the existing ROW of roads side strip plantation declared as Protected Forest without any loss to Forest/Environment.
4. [Clause No. 6.d] - Gujarat Gas Limited, hereby undertake that GGL will seek permission from the local Forest Dept. before carrying out any maintenance if required by GGL.
5. [Clause No. 6.e] - Gujarat Gas Limited, hereby undertake that GGL has proposed to lay pipeline along/across the existing ROW of roads and does not fall in any National Park and Wild life Sanctuary.
6. [Clause No. 6.f] - Gujarat Gas Limited, hereby undertake that GGL has proposed to lay pipeline along/across the existing ROW of roads and size of trench is not more than two meter in depth and one meter in width.
7. [Clause No. 6.g] - Gujarat Gas Limited, hereby undertake that in case of project involve tree felling, GGL has agreed ten trees for each tree marked for removal shall be planted at the cost of GGL in consultation with the local forest department.
8. [Clause No. 6.h] - Gujarat Gas Limited, hereby undertake that we are ready to deposit Bank Guarantee as and when intimated by Forest Department against laying pipeline at subject locations.
