Additional Remarks:-

- I. The proposed CA Plot-I area is in Sy No 63 of Hariharapura village, Kasaba hobli, Shikaripura Tq, Shivamogga Dist. It is a Revenue land and it is mentioned as "Sarkari Muppattu" in RTC Colum No.9
- II. The proposed CA Plot-II area is in Sy No 65 of Hariharapura village, Kasaba hobli, Shikaripura Tq, Shivamogga Dis. it is a Revenue land and it is mentioned as "PWD & Aranya" in RTC Colum No.9
- III. The proposed area for CA land Contains grown tress, This CA Plot-1 and Plot-2 area is a dry deciduous forest and the major species found here are *Tectona grandis*, *Terminalia paniculata*, *Xylia xylocarpa*, *Anogueisis latifolia and Lagerstroemia lanceolata*.
- IV. The proposed area have wild animals like wild boar, deer, sambar, monkeys, etc
- V. This proposed land has a plain terrain
- VI. Annual rainfall here is 1500mm to 2400mm and this area do not have any channels/tanks.
- VII. The proposed CA land is adjoining to Ambligola and Hariharapura village and also adjoining Andandapurm- Shikaripura State Highway.
- VIII. Proposed CA land is 200 meter away from Hariharapura MF (Notification No.G.2378 FT.109-27-78 Dated: 24.08.1929), and Karadibetta S.F (Notification

- No. 23537 .R. 3437 Dated: 19.06.1895) also adjoining to Hariharapura CA area [(FC proposal No FP/KA/Canal/44613/2020 (P.F Notification Number is KFD-01-PCCF(Hoff)-01-2020 Dated: 19.06.2020)].
- IX. The proposed CA land is not included in any section-4 proposed area or in Statutory forest proposal list and it is purely revenue land.
- X. The proposed CA land is free from encroachments, roads and private buildings.
- XI. Forest Department buildings were built in 1.43 Ha area of Plot-2 in Hariharpura village Sy. No. 65.
- XII. The proposed CA land in Plot-1 of Hariharpura village Sy. No. 63 consists of natural forest.
- XIII. The proposed CA land is not a Notified forest.
- XIV. The canopy density of proposed land is above 0.7
- XV. The proposed CA area consists of natural forest, so here it is not possible to raise plantation of 1000 seedlings per ha but ANR model plantation with SMC works can be raised.
