I submit in the reference 2nd cited, it has been mentioned that the user agency has not furnished the essential details sought for by the Principal Chief Conservator of Forests vide letter No. TS3/30434/15 Dt.26.04.2016.In this connection I submit the details called for.

1. The period of diversion of the forest area proposed is 30 years and the same has been proposed in the appropriate place in Form A- segment A-I(x).
2. The undertakings called for in Para No.2 are appended and uploaded.

3. The details of the Compensatory Afforestation land will be submitted as soon as the documents are finalized.
4. We are being small scale industries, I humbly request to reconsider that as per guidelines from the Forest Conservation Act 1980, and the proposed forest area to be diverted is below 1 Ha. Compensatory land in lieu of Diversion of forest land is not insisted. I humbly request that since there is no alternative non forest land is available, we request the approach road stands valid and permitted till the leasing period to our Patta land rather than tied-up to existence of nature of current industry being operated in our patta land.
5. The original Certificate issued by the District Collector(Rc.No. 7913/2010/N1, dated 26.08.2015) about no alternative non forest land available for ingress and egress road to the crusher units along with office seal will be submitted for perusal while furnishing hand copy of the proposal to the this office.
6. We have applied for Certificate regarding completion of process of settlements Rights under the Forests Rights Act 2016 on the Forest land proposed to be diverted. We will upload the Certificate once we receive from concern department.
7. Regarding the clarification on whether the forest land will be maintained as mud road/jelly road.etc., I submit inform that the status quo of the present condition of the forest land will be maintained as mud road.
