NOC IN FAVOUR OF THE PROPONENT AT THE SAID SITE IS HEREBY ACCORDED SUBJECT TO THE FOLLOWING CONDITIONS:

- (i) The proponent shall obtain 'Consent-to-Operate' under sections 25 & 26 of the Water Act, 1974 and Section 21 of the Air Act, 1981 prior to commissioning of the plant from this Board;
- (ii) The effluent (Domestic or Trade) and emission shall conform to the standard prescribed under The Rules;
- (iii) The D.G. Set(s) if any shall be installed with integral acoustic enclosure or acoustically treated room as per the norms of the Board. Accordingly, ANL report shall be submitted to the Board just after commissioning of the unit. The ambient noise level shall conform to the standard.
- (iv) That, license of fire fighting shall be obtained from the competent authority and a copy of the same shall be submitted to this Board. Fire fighting arrangement shall be provided as per the license.
- (v) That, explosive license and other legitimate permission, if any, shall be obtained from competent authority and a copy of the same shall be submitted to this Board before commission of the outlet.
- (vi) Tree plantation all around the campus shall be developed and kept well maintained.
