Dear Sir,

This is with reference to the above-mentioned communications exchanged between your good office and our Company in relation to intake Pipe Line through Village Kumbhargaoon, Gat No. 120 (Old Gat No. 20). In this regard, we would like to submit a detailed reply to your aforesaid letter.

At the cost of repetition, it is reiterated that the said Pipe Line was laid down about 25 years ago and we have checked the relevant documents and records available with us. From the available records, it is observed that there is a letter bearing reference no. 125/96 dated 05th February, 1996 written by Tehshildar, Indapur to the District Collector, Revenue Department, Pune regarding lying down of said intake Pipe Line by our Company [earlier known as M/s Sinar Mas Pulp and Paper (India) Ltd]. A copy of the said letter is attached herewith as **Annexure – A**.

A bare perusal of the said letter clearly indicates that no part of our intake Pipe Line is falling on the land belonging to the Forest Department as our Pipe Line is going through the permissible land limit of Zila Parishad (ZP) which is going from Poundwadi to Kumbhargaoon. A fresh application was also submitted by our Company to change the route of the Pipe Line to ensure that it does not pass through any Forest Land. From the said letter, it appears that all the relevant documents on this subject were submitted by Tehshildar, Indapur to the District Collector, Pune along with the said letter. It is further noted that our Company has paid necessary consideration amount to the respective private owners of the land before lying down the Pipe Line in presence of Talathi of Village Kumbhargaoon and the same is duly acknowledged by Talathi as well as said land owners vide receipts dated 19th February, 1996 and 20th February, 1996. A copy of such receipts (5 in number) is attached herewith as **Annexure – B**.
