With reference to subject, it is to inform that the proposal of ROW for laying of 800mm dia & 600mm dia Iron Ore Slurry line along Biju Patnaik Marg i.e. from Pankapal to Military Chhaka (Danagadi), J.K.Road (left side) at KNIC, Jajpur is here by approved with the following terms and condition.

1. An amount of Rs.21,75,000.00 (Rupees twenty one lakh seventy five thousand)only, (@ Rs.1.50 lakh per K.M. for 14.50 K.M.) is to be deposited as One time non refundable deposit.
2. An amount of Rs.21,75,000.00 (Rupees twenty one lakh seventy five thousand)only, (@ Rs.1.50 lakh per K.M. for 14.50 K.M.) towards performance security, is to be deposited in shape of Bank Guarantee, in favour of Odisha Industrial Infrastructure Development Corporation, Bhubaneswar towards bringing our assets to the pre-damaged condition, so that work is done as per our satisfaction. The bank guarantee is to be kept at least for one calander year and extendable, if required till satisfactory completion of the work.
3. An undertaking shall be furnished that the laying of Iron Ore Slurry line shall be executed on the approved ROW only.
