A meeting was held on 07.07.2020 at 11.00 A.M under the Chairmanship of Sub-Collector, Angul on diversion of forest land for non forest use i.e for construction of B.G railway line under East Coast Railway Corridor between Balaram- Putagadia- Jarapada and one leg upto Tentuloi in the Angul Sub-Division. The officials present in the meeting were as per the list attached at Annexure "A"

At the outset Sub-Collector welcomed the members present in the meeting. The major issues were discussed in the meeting and certified by the SDLC as follows.

1. The ST & other forest Dwellers (Recognition of Forest rights) Act 2006 & Amendment Rules 2012 have been implemented in villages Raijharan, Kundajhari Jungle, Nandichhode/Gopiballavpur, Jhintipal Jungle, Tukuda, Jarapada Jungle, Durgapur, Putagadia, Naupada, Balipata, Hatianali, Balichandrapur, Kankarei under Chhendipada Block

2. The FRC in villages Raijharan, Kundajhari Jungle, Nandichhode /Gopiballavpur, Jhintipal Jungle, Tukuda, Jarapada Jungle, Durgapur, Putagadia, Naupada, Balipata, Hatianali, Balichandrapur, Kankarei under Chhendipada Block have been reconstituted and all individual and community claims have already been settled.

No claim is pending as on today.

3. Due to such a diversion of forest land of 309.751 ha for non forest use, any interest of PTG/PAC has not been affected/ will not be affected for linear projects to be taken up by East Coast Railway i.e for construction of B.G line under East Coast Railway Corridor between Balaram- Putagadia- Jarapada and one leg upto Tentuloi of Angul Sub-Division.
