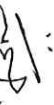

Whereas now MoEF&CC, IRO, Bhubaneswar has communicated through letter No. 7(115)2021-FCE dated 28th June'2023 to the Addl Secretary, Forest & Environment Dept, Govt of Odisha that their DGF&SS, MoEF&CC during a meeting held at New Delhi has advised the State Government of Odisha to submit individual proposals if the User agencies are facing difficulties in filing the same.
