Chief Conservator of Forest (HoFF), Shimla has already advised and confirmed that the name of User Agency has been changed as per Tripartite agreement amongst the Special Secretary (NES) to the Government of Himachal Pradesh cum- Chief Executive Office (Himurja), Shri Bhup Raj and Nand Lal Arora of Shivganga Hydel Power Project. The Pr. Chief Conservator of Forest (HoFF) Himachal Pradesh has, vide its letter No. 48-3907/2019(FCA), already written to the Regional Office, Government of India, MoEF& CCGO Complex Shimla regarding change of name of User Agency
- 6 As per DSS analysis, 1 ha out of 2.5 ha for CA land falls under the Moderately Dense Forest (MDF) category. On our physical verification we have found that most of the area is covered under dense shrubs. The DFO Joginder Nagar is requested to review it and if necessary may kindly revise the CA area having density less than 0.4 and comply with requirements of Point No. 6 (i) and 6 (ii).

Sir, it is submitted that almost all queries raised by Regional Office, IRO, Shimla, have to be complied with at the level of the DFO Joginder Nagar, Pr. CCF(HoFF) Shimla and the State Government which may take a long time. It is very humbly requested that this case may be considered favourably and the same may be forwarded to the MoEF& CC, New Delhi for granting approval of Stage 1.

**Replay to Objections / Queries raised by Regional Officer, IRO Shimla  
letter dated 01.09.2022**

1. The issue of review of aerial distance from nearest Nargu Wild Life Sanctuary concerned, it is 05 Km from the notified Zone and 04 Km from Eco Sensitive Zone. The DFO Joginder Nagar and Nodal Officer (FCA) are requested to provide the reason for the difference as per DSS analysis as provided by PCCF (CWLW) and the DFO concerned. The DFO is also requested to see, if any change has been made in the Boundary of WLS which might have resulted in the difference between the State Government and the MoEF&CC distance.
2. So far as the issue of Transmission line is concerned, it will be Single Line circuit as per the Diagram submitted by Superintending Engineer (OP) circle HPSEBL.
3. The issue of "KARAM" in Mandi District, except Chamba District, is already under consideration at MoEF&CC and the State Government is requested to take up the issue of universally accepted system of land measurement possibly in METERS as unit of measurement. Until and unless Government of India and Government of Himachal Pradesh adopt universal system of land measurement till then we may be allowed to follow the existing system of land measurement.
