With reference to the above subject, Sri. V.V Babu, DGM, CEO, jio Digital Fibre Private Limited, Bengaluru" has applied for diversion of 0.1004 Ha land for laying JIO Underground OFC Cable from Samse to Kalasa through Reserve Forest, Section 4 Notified and Deemed Forests in Samse and Mavinakere villages of Kalasa Taluk of Koppa Division, Chikkamgaluru

District through online vide proposal No. FP/KA/OFC/15312/2022. The proposal was accepted by the Nodal officer, the proposal received by this office for Verification and submission of Site inspection report.

The Range Forest Officer, Kalasa Range and Assistant Conservator of Forests, Balehonnur Sub Division, Balehonnur has inspected the site and report submitted to this office Vide ref (5) and (6) cited above.

As per the site inspection report of the Range Forest Officer, Kalasa Range and Assistant Conservator of Forests, Balehonnur Sub Division, Balehonnur, the underground OFC cable passes through Samse and Maviankere villages to an Extent of 0.1232 Ha instead of 0.1004 Ha as against the proposal submitted by the user agency. The Proposed area is in the category of Reserve Forest, Section 4 Notified Forests and Deemed forests of Kalasa Taluk. The Underground OFC cable passes along the the State Highway -66 and does not require tree felling.

The Above area has been inspected by me on 22-07-2024. The User Agency Submitted the proposal for Diversion of 0.1004 Ha of Forest land for laying of Underground OFC cable, after the field Verification it is found that the actual area covered is 0.1232 Ha of forest land. The Remaining extent does not comprises of forest land which is either malki land or govt land.

### 2. Net Present Value(NPV)

It is submitted that the above areas falling under Eco-Class-I (Semi- evergreen very dense Forests).. The proposed area is not falling in National park/Sanctuary and no felling of tree is involved. Hence there is exemption on NPV is accorded as per MOEF order vide order No:5-3/2011-FC(Vol-I) dated 6 th January 2022 vide Ref No(3).

### 3. Compensatory Afforestation(CA)

It does not attract Compensatory afforestation also since the Diversion of Land is Less than 1.00 Ha. But Compensatory Planting Cost required to be Collected considering Minimum of 16 Plants, even though no felling of trees involved. Hence Compensatory planting charges to be collected vide Ref No (4).

The Proposed forest Land is not part of National park, Wild life Santuary, Biosphere Reserve, Tiger Reserve and Elephant Corridor etc. The Proposed Forest Land within the Eco-Sensitive Zone of Kudremukha National park notified under wildlife (Protection)Act 1972. Hence the Proposal requires approval by the Monitoring Committee.

The Proposed Diversion of 0.1232 Ha of forest land for Installation of Undergroudn OFC cable between Samse to Kalasa involving various sy no's in Samse and Mavinakere Villages of Koppa forest Division is recommended for approval under VAN (SANRAKSHAN EVAM SAMVARDHAN) ADHINIYAM, 1980.
