Sir,

This is regarding the approval for for laying of underground pipeline along the NH-34 (Old NH-86) from Ch. 67.000 to Ch. 111.900 (Approx. length Km. 32.000) and crossing at different locations at Ch. 67.700, 84.390, 93.380, 93.700, 99.540, 100.900 & 106.900) in the State of U.P granting permission in the State of U.P as submitted by you.

- In view of above, the Competent Authority has conveyed the approval and further Competent Authority has authorized Project Director on behalf of NHAI for signing of License Agreement after the completion of 30 days of application on public domain. The above approval is subject to ensure the compliance of following conditions before according permission:
- i. Applicant undertakes that no other structure will be erected nor any other service rendered within the ROW of NH without prior permission of NHAI.
- ii. Applicant will ensure that all safety measures will be taken during execution of works at site.
- iii. If any adverse comments received against the instant NOC, then approved NOC may be treated as cancelled until further clarification/ approval.
- iv. The minimum time period of Bank Guarantee as per Ministry Circular No. RW/NH-33044/29/2015/S&R(R) dated 22.11.2016 is 01 year. Hence, applicant may be requested to extend the BG validity date.
- 3. It is requested to submit the confirmation of license fee deposited in "Bharat Kosh" through online before signing the License Agreement.
- The above approval is subject to ensure the compliance of following conditions before according permission:-
- The laying work will be done as per the proposed/ agreed location route and as per proposed layout plan.
- iii. The Licensee shall have to provide the safety measures like barricading danger lighting and other necessary caution boards while executing the work.
- iv. Appropriate fees be levied for use of NH land for laying of Utilities as per Ministry Circular No. RW/NH-33044/29/2015/S&R(R) dated 22.11.2016.

Further, the Bank Guarantee No. 03193IG22000090 dtd. 16.06.2020 amounting to Rs. 57,31,000/- issued by Indian Bank Allahabad, valid upto 13.06.2023, if the work is not completed within time, the same shall be extended by the applicant.

In view of above, it is requested to furnish all the above documents/ undertakings at the earliest, so that the agreement for above work may be executed. It is further requested not to start any construction activity before execution of the agreement.
