Dear Sir,

Please find point-wise reply of queries in reference to above referred letters as follows:

i. The state shall provide the details of other projects of the user agency which are proposed to be used for over burden dumps, Belt, CHP & Siding etc. The details of forest land diversion in these projects along with status of compliance of the stipulate conditions under FCA shall also be provided.

**Reply-** No overburden will be dumped in any other project. As indicated in Project Report, overburden quantities will be dumped within quarry area of instant project. (Copy of Mining plan showing Stage Plan enclosed).

In project report, it has been proposed to utilize the existing CHP, Siding and transportation road of adjacent coal mining project namely Rajnagar RO Underground mine.

#### Status of Forestry Clearnce of Rajnagar RO Underground mine -

Stage-I Forestry Clearance was obtained on 10.01.2008 for "**Renewal of 502.00 Ha Forest land for Underground mining right and 123.56 Ha Forest land for surface right**" (Proposal No. FP/MP/MIN/1384/2006). Further, the FC proposal was considered in FAC meeting on 26.07.2018 wherein Committee members recommended that-

- I. State Government shall submit the status of CA carried by State Government in lieu of the diverted forest land for which renewal proposal is under consideration of MoEF&CC. If the CA done in the past against the same land is as per MoEF&CC guideline, No CA shall be insisted upon on renewal of approval. If there is gap between the requisite CA as per the guideline and actually carried out in the field then the balance CA shall be raised over degraded forest land equivalent to double the extent of the gap. State Government shall submit the revised CA scheme accordingly.
- II. Compensatory afforestation, if done, shall be done as per the MoEF&CC guidelines dated 08.11.2017.

III. MoEF&CC shall take the matter related to payment of NPV with member Secretary CEC. The amount paid by user agency against NPV of the area shall be reconciled with CEC, User agency, State Government and Adhoc CAMPA.

Subsequently, the PCCF (LM), Bhopal in its letter dated 05/07/2023 informed about non-availability of records relating to CA sites; further seeking consent of mine authorities for re-payment of amount for carrying out new CA schemes. State government is yet to submit its reply in compliance with FAC recommendations.

Compliance status of Stage-I FC is enclosed.

ii. The State shall revisit the Compensatory Afforestation areas keeping in view the observations raised by the Regional Office in Site Inspection Report and take corrective measures accordingly.







I am directed to refer to Nodal Officer (FC), Madhya Prudesh Letter No. 1-1/428/06/10-11/2598 dated 23/11/2006 on the above mentioned subject, wherein prior approval of the Central Government for the diversion of 502.00 ha. of forest land for renewal of lease for Rajnagar RO / Under- Ground Coal Mining project in Anup-ungar District of Maduya Pradesh in favour of CGM Hasdeo region of SECL, and also diversion of 123.56 ha. forest land (a part of 502.00 ha.) for surface use for the same project, was sought, in accordance with Section 2 of the Forest (Conservation) Act. 1980. The said proposal has been examined by the Forest Advisory Committee constituted by the Central Government under Section 3 of the aforesald Act.

The State Government shall charge Penal Interest on the payment of the Net Presont Value w.e.f. 25.10.2004 i.e the date of grant of Temporary Working Permission, on which date the NPV had become due.

Additional amount of the NPV of the diversed forest land, if any, becoming due after finalization of the same by the Hon'ble Supreme Court of India on receipt of the report from the Expert Committee, shall be charged by the State Government from the User Agency. The User Agency shall furnish an undertaking to this effect.

The User Agency shall fence, raise and maintain plantations of suitable tree species on the surface area of the mine.

No damage shall be caused to the top-soil and the surface area of the mine. If any damage to the top soil and the surface area of the mine is reported, than the User Agency shall raise and maintain Compensatory Afforestation and Penal Compensatory Afforestation as may be stipulated under rules.

xiv. The State Covernment / User Agency shall initiate action against the persons involved in the violation of the Forest (Conservation) Act, 1980, and submit an action taken report to the Ministry of Environment & Forests within a period of six months.

xv. The Regional CCF. Bhopal shall take immediate legal action for violation of the Forest (Conservation) Act, 1830.

xvi. The forest land shall not be used for any purpose other than that specified in the proposal
xvii. All other conditions stipulated by the State Government of Madhya Pradesh at the time of
submission of the proposal shall be complied with by the User Agency.

xviii. Other standard conditions as applicable to proposals related to underground mining / surface rights shall also be applicable in the instant care.

3. After receipt of the compliance report on the fulfilment of the above mentioned conditions contained in Para 2 above, from the State Government of Madhy a Pradesh, formal approval will be issued in this regard under Section-2 of the Forest (Conservation) Act, 1980. The transfer of forest land to the User Agency shall not be affected by the State Government till formal orders approving the diversion of forest land are issued by the Central Government.
