Sir.

l am directed to refer to your letter No. EDN(TE)-A(1)-25/2009 dated 09.11.2009 on the subject cited above and to say that the matter has been examined in FD regarding establishment of Technical University . FD comments in the same cause as follows:-

- Finance Department concurs, in principle to grant of loan for the proposed University, to be returned to the State Government, with in one year after the University is established, since the University is to be funded from own sources on a self financing basis.
 - ii) The University would be given the loan amount based upon the estimates of recurring and non recurring expenditure furnished by it and furnishing of UC_son past utilization of funds.
 - Since, the University is to be run on a self sustaining basis, the proposed clause on grant by the State Government at page-38 of the DPR needs to be deleted.
 - building up the initial corpus, and until the loan is returned to the State Government, all posts/positions to be created in the University may be done with the approval of the State Govt. The AD may however, consider empowering the University with the power to create or sanction posts/new positions once the

Other office support for Secretariat, Data Entry, housekeeping security, vehicles etc. may be outsourced to private service providers. The proposed University may be given a free hand to engage out side



consultants/ specialists for campus development, architectural services, financial services etc. as consultancy assignments. Finance Department has also concurs to the purchase of a Vehicle for the Vice Chancellor, while for other officers/ officials use, suitable taxis would be leased by the University on a need basis.

Some of the pay scales including that of the Vice Chancellor are not as per approved norms. Department may ensure that there is no deviation with respect to the pay scale as approved in other organizations/ Universities. Since, in the first phase, the University would be mostly undertaking planning, monitoring, examination related and curriculum development activities, initially only the aforesaid posts may be created and filled up. The Department may seek further approval for faculty posts, once there is a need for the same and the University becomes fully geared up for academic / teaching work.
