**NON AVAILABILITY OF NON FOREST LAND CERTIFICATE**

Certified that no alternative suitable non forest land is available for the purpose of widening-four laning of National Highways-22(Now new NH-05) from Solan-Kaithlighat at Village Kathali, Tehsil Kandaghat, District Solan. Therefore diversion of land measuring 2.4589 Hectare, though recorded in the ownership of private persons yet claimed by the Forest Department as forest land is essential and cannot be avoided. The details of Forest Land, on the basis of joint inspection report under FCA 1980 is given as under subject to the following conditions:-

**Conditions:-**

1. Since the land described above is recorded in the ownership of private owners and the forest department has claimed it to be forest land(D-227 Raikot), a civil suit for correction of revenue entries is pending adjudication in the Court of Civil Judge Kandaghat, therefore, the certificate shall be subject to the outcome of the civil suit.
2. In the event of decision of the Court in favour of the private owners, the NHAI will deposit the amount of compensation with Land Acquisition Collector(CALA), Solan qua the land described above as directed by the Hon'ble High Court of H.P in CWP No. 5537 of 2020 titled as NHAI V/s State of H.P & Others decided on 08-12-2020.
