The main objectives are</p> <ol style="list-style-type: none"><li>The proposal for grant of permission in RF Land to an extent of 4.91 ha, is for development of infrastructural facilities like buildings and other infrastructural facilities for school of Horticulture in the State (Multi sectorial disciplines). The building and the infrastructural facilities will facilitate in housing the state level scientific / administrative officials.</li><li>To establish an unique, innovative and world class School of Horticulture with (Multi sectorial disciplines in Horticulture).</li><li>To attain State of art excellence in horticulture and allied sectors for education, research and dissemination of research technologies to meet the demand on horticulture production and productivity at national and global level.</li><li>The administrative sector officials located in the building will have an over all control and monitor the ongoing education, research on horticulture and allied areas in the already existing colleges and research centres located in various districts of the State.</li></ol> <p><b>Note: Already 4.922 Ha has been accorded In Principle (Stage- I) Vide GoRT No. 138, EFS &amp; T Dept, Dt: 27/7/2015. d	Justification for locating the project in Forest area	<p>(i) For better outreach and education in the field of horticulture to the next level of excellence.</p> <p>(ii) The proposed Telangana school of Horticulture, Mulugu is a first of its kind in the Country.</p> <p>(iii) The proposed area will be utilized for development of building and infrastructural facilities to the proposed project.</p> <p>(iv) The climate &amp; soil of the area is very much congenial for horticultural crops.</p> <p>(v) The fields in surrounding cluster villages are predominantly the vegetable growing belts and also the horticultural plantation.</p> <p>(vi) establishing the School of Horticulture will definitely help in creating access to the farmers of the State to interact with the horticultural crop specialists to orient themselves to the latest improved technologies for improving the production and productivity of the horticultural crops.</p> <p>(vii) The School of Horticulture will also help in skill up gradation and imparting vocational training to the farmers of the State.</p> <p>(viii) The technologies generated in the already existing horticultural research centres in the State can also helps in skill up gradation of the farmers in the State.</p> <p>(ix) One of the Premier and Prestigious Fruit Research Station, Sangareddy is located in the district, will helps in skill up gradation of the farmers in particular the district and the state as a whole for horticultural crops.</p> <p>(x) Total extent of 4.91 ha is proposed for grant of permission for establishment of Telangana School of Horticulture. This will improve the productivity of the existing lands and thereby aiming to achieve the national goal of achieving 33% of tree cover in the State of Telangana. This will also provide a conducive atmosphere for improvement of bio-diversity and ecosystem services.</p>


