 The data sources are the students' learning outcomes, which will be measured using a standardized test.

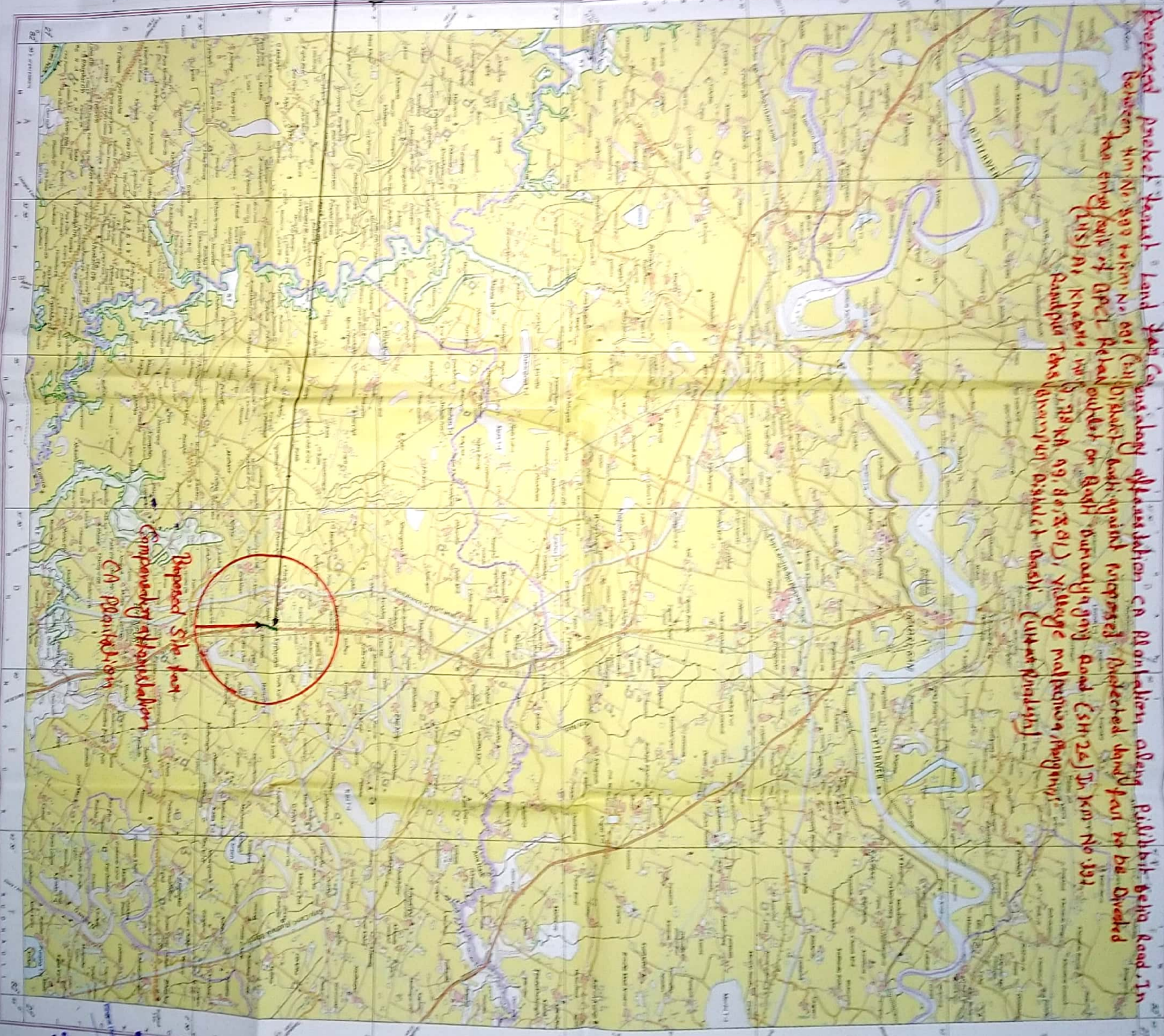
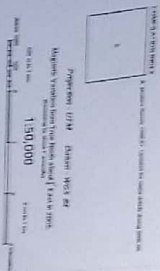
7. **What are the data analysis techniques?**
