We, M/s Greenko Solar Energy Private Limited, are proposing to develop a Standalone Pumped storage Component (1260 MW) of Saundatti IREP in Belagavi district, Karnataka. The establishment of this Integrated project with Solar, Wind and Pumped storage components has been approved as per Government of Karnataka. Presently, we are in process of obtaining required statutory clearances for our project implementation.
