





History and Nacessity The proposed road and allied links having length of 6.00 Km takes off from Mangna to Sanan Paid Road. The population benefitted by construction of this road is approximately 500 souls. The inhabitants of the area suffer in the absence of a motorable road. The source of livelihood of these people is agriculture and vegetable production. But due to lack of road connectivity the people of the area have to face lot of difficulties. Especially during rainy season, the sick people, school going children have to move on foot to reach the main road. To apprise of the difficulties faced by them, a deputation of the area met the Advisor to Hon'ble Governor of J&K, Jammu and requested for the dressal of their grievances. Accordingly, to address the problem of the people, the present Application for Administrative Approval for the said work has been framed.

Brief Specification :-

The road should be constructed as per IRC specification. Earthwork in cutting shall be done in 6.0 Mtr average and after obtaining formation width of average 6.0 m, compacting the formation. Necessary Cross Drainage, Hume pipe culvert, drain protection work to drain off surface run off has been kept in provision and should be constructed as per necessity at site.
