1. To appear before the Registrar and Sub-Registrar of Assurances in any District or Sub-District appointed to register the documents under the law applicable thereto for the time being in force for the registration of documents and to present for the registration the deeds, agreements and other documents executed by the Attorney on behalf of the Company as may be necessary or proper for the effectual completion and registration of the said documents and all other deeds and documents so executed in the Office of Land Registrar, District Collector and other Revenue / Government Authorities.

To apply and obtain Digital Signature Certificates on behalf of the Company and to affix such Digital Signature on any application, letters and/or technical drawing or any other documents to be submitted to any of the aforesaid statutory authorities in connection with the aforementioned businesses of the Company.
