I would like to inform that the Combined Water Supply Scheme (CWSS) to Tambaram-Pallavaram is being maintained by TWAD Board to provide water supply to Tambaram, Pallavaram Municipalities, Chitlapakkam, Thiruneermalai Town Panchayats and other Government organizations.

The Government of Tamil Nadu has approved the more than 35 years aged Tambaram-Pallavaram CWSS for revival of outlived components under Capital Grand fund under 5th State Finance Commission vide ref 1st cited. The 600mm AC pipe line laid from Global Automotive Research Centre to Krishna Nagar Booster station at Tambaram comes under middle of BT road due to widened road, which is occurring frequent leak & burst. Hence 600mm AC pipe has been proposed to be replaced with 600mm DI pipe and proposed to lay in Right of Way of highways (ROW). Necessary highways permission was obtained vide letter in ref 2nd cited.

In the above proposal 600mm DI pipe has been proposed to be laid in highways ROW at KM 44/905 to 45/200, which is adjacent to Vattambakkam Reserve Forest land in Tambaram Range and the same land was already handed over to highways department for road widening work vide ref 3rd cited.

Further I assured that the proposed pipe line will be laid in ROW of highways already shown by Highways department and wouldn't enter in the adjacent Forest land for any purpose. This is for favour of Kind information.
