
Reply to the EDS raised by Nodal Officer vide letter No. F14()2020/OFC/FCA/PCCF/EDD-1 dt. 12/20/03/2020 & 7 August 2020, Pointwise reply/compliance is as follows:

A-1 Project Details	1. The project detail is not given. The detail of OFC line should be given (Distance, from where to where etc.)	Now desired details have been provided in point A-1.
B Details of land required for forest	1- Details of all proposals submitted in past & under processing should be given. 2. Land details should be given up to 4 decimals 3. Village wise breakup, land required for diversion is not given	1- details of all proposal submitted has been given. 2- Has been given up to 4 decimals. 3. We humbly submit that we are not seeking diversion of Fresh Forest Land. The application is for seeking permission to lay underground OFC in ROW of existing road from PWD as well as Forest Department under General Approval. It is linear activity. We also submit that our activity will be carried out in ROW whose right to use is with PWD. Our land use is temporary & one time affair. The land of ROW will be restored as desired by PWD in their permission and also as desired by Forest Department in theirs. The activity will be restricted to ROW only. It is humbly submitted that this activity is exempt from depositing the NPV. Village wise details sought by you may please be waived off.
C Maps of forest land proposed to be diverted	1- The area of KML is different from the area required for diversion, so rectify KML, TOPO Sheet & DGPS accordingly. 2- TOPO Sheet should be given at 1:50,000 scale with entry exit chainage in forest land. 3- Proper DGPS map with all coordinates should be uploaded.	1. Area has been rectified. 2. Concerned portion of GT Sheet showing length of road along with Entry & Exit wherein U/G OFC in RoW will be laid has been uploaded. ORIGINAL GT Sheet with R.F 1:50,000 will be provided when hard copies of the proposal will be asked by the department. 3. GPS map is uploaded
D Justification for locating the project in forest land & details of alternatives examined:	1. In justification, the proposal name with area to be diverted and proposal number should be given.	1. Name of proposal with area required and proposal number has been given here also.

All undertakings i.e. NPV, CA Amount, minimum use of forest land, other conditions, no use of forest produce, cross section of OFC line, Muck disposal plan etc. should be submitted in additional information should be given in MoEF format. 5. Cross section of OFC line	1. Sanction has been attached. 2. Area calculation sheet has been attached. The GoI have granted general approval under S/2 of FCA, 1980 for diversion of forest land for certain CRITICAL PUBLIC UTILITY SERVICES/STRATEGIC DEFENCE INFRASTRUCTURE. U/G laying of OFC etc. along roads within existing RoW is one of such activities. In execution of these work maximum size of trench should be 2.00 meter deep & 1.00 meter wide. Seeking khasra/village wise details is not desirable for activities to be done in RoW of existing roads which are covered under general approval granted by GoI. Form-'A' Part-I to be filled up by user agency) for seeking prior approval under S/2 of the proposals by the State Governments and other authorities does not seek khasra/village wise details. 3. Bar chart has uploaded now. 4. U/G laying of OFC is exempt from NPV as per order dated 28/3/2008 of Hon'ble SC of India. As per Order No.11-9/98/FC dated 15/6/2004 of MoEF, GoI question of CA does not arise. Minimum use of forest land is done by us. No use of forest produce is done while laying OFC & muck disposal plan uploaded. 5. Cross section of OFC line is enclosed.
