- You are directed to furnish the progress of Establishment of plant and machinery, green belt, Effluent Treatment Plant and Air pollution control devices, by 10th day of completion of subsequent quarter in the Board.
- Copy of the work order/purchase order, regarding instruction and supply of proposed Effluent Treatment Plant/Sewerage Treatment Plant /Air Pollution control System shall be submitted by the industry till 15/09/2025 to the Board.
- Industry will not start its operation, unless CTO is obtained under water (Prevention and control of Pollution) Act, 1974 and Air (Prevention and control of Pollution) Act, 1981 from the Board.
- It is mandatory to submit Air and Water consent Application, complete in all respect, four months before start of operation, to the U.P. Pollution Control Board.
- Legal action under water (Prevention and control of Pollution) Act, 1974 and Air (Prevention and Control of Pollution) Act, 1981 may be initiated against the industry With out any prior information, in case of non compliance of above conditions.

#### Specific Conditions:

- This consent is valid only for white category industry, which is exempted from seeking CTE from Board Policy. However the proposed project falls in TTZ area. Thus unit has to comply with the directions given time to time by the Hon'ble Court /TTZ Authority / State Pollution Control Board.
- This consent to establish (CTE) is valid only for Petrol pump retail outlet.
- No water and air pollution source will be added/ installed by the unit without prior permission from State Pollution Control Board.
- Environmental statement will be submitted annually before the end of month of September every year.
- This consent(CTE) is valid only for domestic water consumption and sewage discharge.
- Prior consent to establish (CTE) is mandatory to be obtained for any process change or addition in capacity in production or change in product.
- Proper acoustic arrangement will be provided on compressor kit to minimize sound pollution.
- The unit is not allowed to increase the capacity of generator sets without prior permission from TTZA/ State Pollution Control Board.
- That the investment of the industry is not more than Rs. 5 Crore on plant and machinery.
- That there will not be any discharge of trade effluent from the industry into stream or well or sewer or onto land and/or that industry will not discharge any air pollution including noise into the atmosphere.
- That the petrol pump will not discharge any toxic/hazardous wastes and will not handle any toxic/hazardous chemical. The unit shall OPT for control measures to CWB the gaseous emissions generated during fuel filling of the vehicles.
- That the petrol pump which fall under white category of industries should not install stand-by DG set of capacity more than 15 KVA (acoustically enclosed).
- Regular Compliance report of consent(CTE) should be submitted to State Pollution Control Board.
- The Retail outlet shall bring minimum 33% of available open land under green coverage/plantation.
