The project envisage the use of laying of Under Ground Optical Fiber cable with HDD method THRU installation of Poles on Setia Petrol Pump to Idgah Road Mod (680 Mtr. Thru HDD purane Darwaje Khidki wale to M/s. Chintu Boot House, opposite Choudhary Hospital on Jattal road in Panipat Distt. Haryana for diversion of 0.0450 ha. 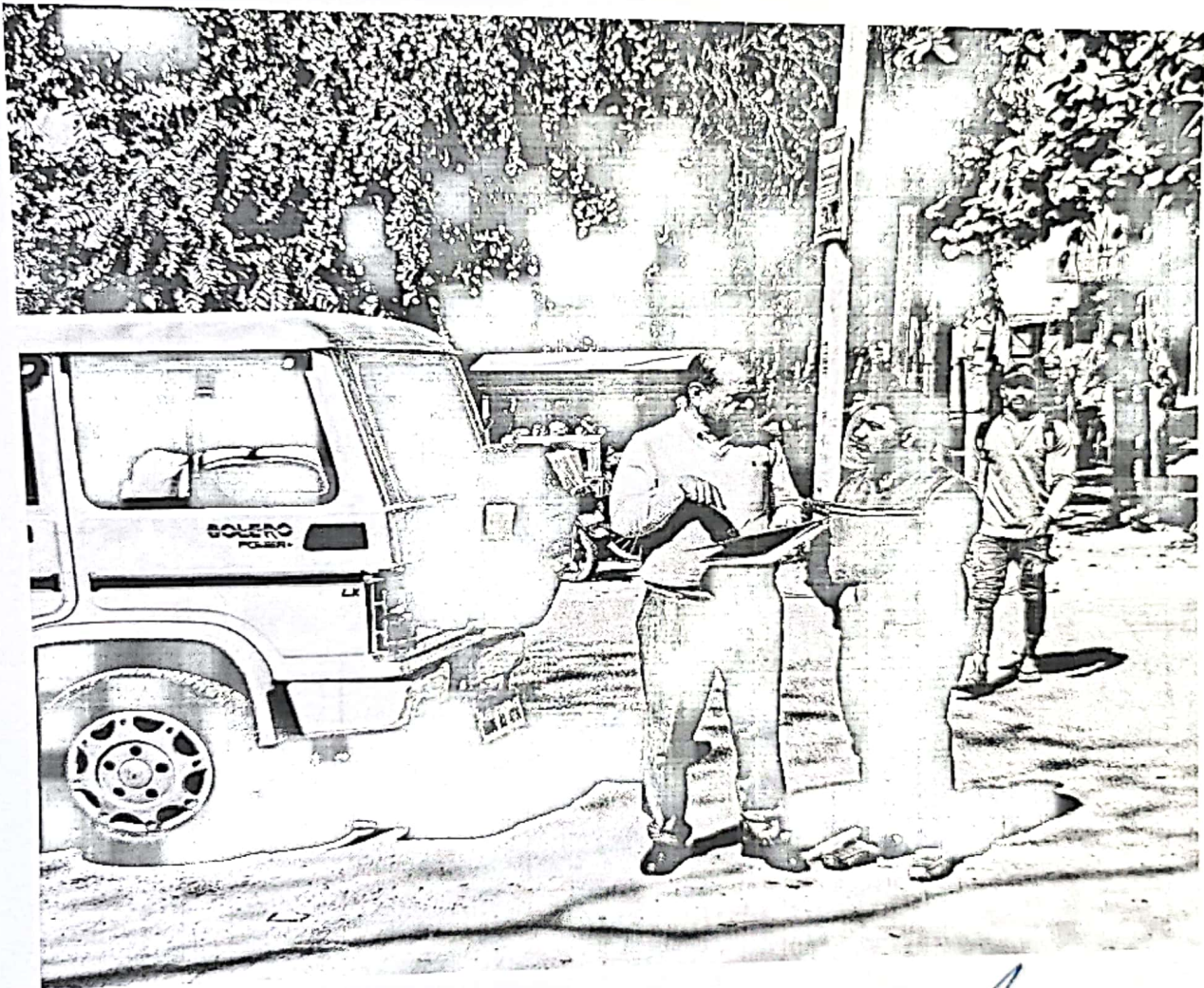
