Summary record of decisions of TC 578/03.05.2013 issued vide Secretary (Board) letter no. F.4()/TC 578/RWSSMB/ 2013-14/506-530 dated 13.05.2013 were confirmed.

The agenda item was considered in light of the comments of TM, and FA&CAO and presentation made by CE(R), PHED, Jaipur. During presentation, it was informed by the CE that in view of problem of drinking water in 5 villages of tehsil Gogunda during summer, which are benefitted by hand pump schemes but hand pumps get dry during summer, a regional scheme has been framed with source as open wells on the bank of river Banas. He informed various provisions included in the proposal and requested to technically clear the proposal for A&F sanction. Agenda item was deliberated in detail. During deliberations, the Committee agreed in principle with the proposal, however, it was desired to modify the scheme in light of comments / observations of TM and FA&CAO. After deliberations, it was decided to in principle technically clear

the proposal for A&F sanction by the competent authority. Proposal for A&F sanction shall be resubmitted for consideration of PPC after revising/ modifying the scheme in light of the observations of TM and FA&CAO.

The agenda item was considered in light of the comments of TM and FA&CAO and presentation made by CE(SP), PHED, Jaipur. During presentation it was informed that A&F sanction of the Project was accorded "on file" for Rs. 955.00 Crs. and current proposal is for technical sanction of Package-2 of the project. It was further informed that technical sanction of package-1 has already been accorded in TC 576/17.04.2013 for basic cost of Rs. 564.10 Crs. Various provisions included in the package were also informed in brief. The agenda item was deliberated in detail. During deliberations, CE(SP) confirmed that the proposal is based on actual field survey, the provisions taken in the package are as per sanctioned project and are in accordance with the guidelines/policies of the department including the pipe policy. He also informed that the reservation of water in Indira Gandhi Nahar and its system for drinking water has already been agreed in principle at Administrative Department level and also in the meeting held at the level of Chief Secretary, Rajasthan. He requested to accord technical sanction to the submitted proposal. After deliberation, it was decided to accord technical sanction to the package for basic cost (including 10 years O&M) of Rs. 438.51 (Annex.-1/AI-3/TC 579/ 14.05.2013) subject following:-

- ➤ Provision for surge design from IISC Bangalore/other approved institution and providing surge protection devices accordingly, shall be made part of tender document for the work.

During presentation it was informed that A&F sanction of the project was accorded "on file" for Rs. 231.46 Crs. and current proposal is for technical sanction of the project. Various provisions included in the proposal were also informed in brief. The agenda item was deliberated in detail. During deliberations, CE(SP) informed that the proposal is based on actual field survey, the provisions taken in the package are as per sanctioned project and are in accordance with the guidelines/policies of the department. He also informed that adequate water for the project is available in Bisalpur Dam and the existing system from Bisalpur Dam to Beawar includes the provision for designed demand of the instant project. He requested to accord technical sanction of the proposal. During presentation it was informed that revised A&F sanction of Reorganisation of UWSS Jalore based on Narmada Canal water including coverage of 14 nos. villages from the system of the scheme was accorded "on file" for Rs. 62.20 Crs. He further informed that the work of the scheme is proposed to be executed in 3 packages, out of which technical sanction of 2 packages have already been accorded and the current package i.e. Package-III is for distribution system of 14 villages. Various provisions included in the current package were also informed in brief. The agenda item was deliberated in detail. During deliberations, CE(SP) informed that the proposal is based on actual field survey, the provisions taken in the package are as per sanctioned project and are in accordance with the guidelines/policies of the department. He requested to accord technical sanction to the submitted proposal. After deliberation, it was decided to accord technical sanction to the package of the scheme for basic cost (Including O&M for 10 vears) of Rs. 1137.76 lacs (Annex.-3/AI-5/TC 14.05.2013) subject to following:-

During presentation, it was informed by the CE that tender document of 5 star rated ISI marked submersible pump sets is already approved and the instant proposal is for approval of technical specifications for the submersible pumping sets of higher KW rating, which are not covered in 5 star rating by BEE. Variation in provisions of the instant tender document including specifications from the already approved tender document of ISI marked 5 star rated submersible pumping sets, were informed in detail with the reasons of required change/ variation. The agenda item was deliberated in detail and after deliberations, it was decided to approve proposed changes in technical specifications of the ISI marked submersible pumping sets having motor output more than 15.0 KW, as mentioned in the agenda note and subsequent reply by CE(HQ). The tender document shall be revised accordingly with all logical modifications.

He proposed breakup of the sanctioned scheme in 4 packages for early execution of the proposal and to provide relief to the public at the earliest possible. During presentation, it was informed that revised A&F Sanction of the scheme was accorded 'on file' for Rs. 62.20 Crs. and technical sanction of package-II was accorded in TC for basic cost of Rs. He proposed sub breakup of the technical 28.91 Crs. sanctioned package-II in 3 packages for the purpose of execution/ implementation. Justification of proposed sub packages was also informed in brief and he requested to approve the proposed sub break up. The agenda item was deliberated in detail. After deliberations, it was decided to accord in principle approval of sub breakup of package-II of the scheme in 3 packages i.e. (A) Works to be taken under SPR contract, (B) Works for non SPR contracts and (C) Work of distribution net work for future development for the purpose of execution, as recommended by CE(P), PHED, Jodhpur. Works under these sub packages shall be taken up as per the technical sanction accorded by TC.

Agenda Item No.9: Revision in cost of TS for Cluster Scheme of 161 villages of tehsil Phagi under Bisalpur Dudu Water Supply Project.

The agenda item was considered as per presentation made by CE(SP) and SE, DTU Circle, Jaipur. During presentation, it was informed by the CE that Technical Sanction of the package was accorded for basic cost (including 10 years O&M) of Rs. 177.99 Crs. in TC 576/17.04.2013 with provision of 294.3Km. 63mm UPVC pipelines for intra village distribution. It was further informed that in view of GOI (NRDWP) ultimate objective for coverage of maximum villages through house connections, the size of pipelines has been revised from 63mm to 75mm with revision in cost of the package to Rs. 179.01 They requested for revision in cost of the technical sanction of the package with above modification. The agenda item was deliberated in detail. After deliberations, it was decided to revise the cost of already accorded technical sanction of the package as Rs. 179.01 Crs. (Annex.-4/AI-9/TC 579/14.05.2013) including O&M for 10 years.

Agenda Item No.10:

Categorization of makes of item used in water supply project. The agenda item note submitted by the Technical Member was further deliberated in continuation to earlier deliberations in the Technical Committee. The proposed criteria for short listing of makes / manufacturers were discussed in detail. With the objective of ensuring use of only good quality of materials in water supply schemes/ projects, after deliberations, following parameters / criteria for short listing of makes/ manufacturers were decided for 3 basic items i.e. uPVC pipes, Submersible Pumping Set and Valves:-

uPVC PIPES:

- The annual turnover of the company should be equal to or more than Rs. 300.00 Crs.
- The company should have in house facility for testing of raw materials.
- The company should have automatic mixing system of raw materials.
- The company should have certification of BIS, ISO 9001, ISO 14001 & OHSAS 18001 (Occupational Health and Safety Management Systems).
- The company should have all testing facilities for the product as per relevant BIS.

Submersible pump sets:

- The annual turnover of the company should be equal to or more than Rs. 250.00 Crs.
- The company should have installed annual manufacturing capacity of 50,000 or more submersible pumping sets.

- The company should have its own Foundry unit.
- The company should have certification of BIS, ISO 9001, ISO 14001 and BEE 5 star rating.
- The company should have all testing facilities as per relevant BIS.
- The company should have its authorized service centre in Rajasthan.

Valves:

- The annual turnover of the company should be equal to or more than Rs. 50.00 Crs.
- The company should have its own Foundry unit and for manufacturing of DI valves, the firm should have Induction Furnace in its Foundry unit.
- The company should have certification of BIS, ISO 9001 and ISO 14001.
- The company should have all testing facilities as per relevant BIS.

On the basis of above criteria and available information, following makes/manufactures were short listed for use in water supply schemes/ projects of PHED Rajasthan:-

It was also decided that before implementation of above short listing process, the case shall be submitted for administrative approval.

The agenda item was considered as per presentation made by CE(SP). During presentation, it was informed by the CE that in view of large nos. of ongoing and sanctioned major drinking water supply projects and further likely sanctions, huge quantity of DI pipes are required for pumping mains as per existing Pipe Policy of the department. He further informed that timely availability of these pipes for execution of projects in schedule period seems doubtful in view of present capacity of the manufacturers. Raising of above issue by various contractors during the contract review meetings was also informed. In view of above, he proposed to include Bar Wrapped Steel Cylinder (BWSC) pipe, which is a semi metallic

pipe, as an alternative to DI pipe in Pipe Policy for sizes up to 600mm. BWSC pipe was reported to be structurally safe and 10 to 25% cheaper than DI pipe. Increase in availability of pipe for pumping mains due to inclusion of BWSC pipe was also reported.

deliberated The agenda item was in detail. During deliberations, it was the view of the Committee that as department has not much used BWSC pipe in past and performance of the same for longer period is not practically known to the department, therefore, instead of considering of BWSC pipe up to 600mm for pumping mains, size from 250mm to 400mm should only be considered. It was also viewed by the Committee that to ensure only good quality of BWSC pipes, rider of supply of these pipes from the manufacturer having experience of more than 3 years manufacturing should also be considered. In view to ensure availability of adequate quantity of pipes for pumping mains as per pipe policy of the department, without compromising performance of the pipeline and with other techno-economic parameters, after deliberations, it was decided to recommend inclusion of BWSC pipe for pumping mains from 250mm to 400mm dia in pipe policy of the department subject to that the manufacturer of pipe should have experience of manufacturing of more than 3 years.

It was also decided that above recommendation of Technical Committee shall be submitted for approval of competent authority.

During presentation, it was that the instant project is part of budget announcement of Hon'ble Chief Minister, Rajasthan during budget session 2013 and accordingly, A&F sanction of the accorded 'on file' for Rs. 254.45 Crs. It was further informed that proposal for Technical Sanction of the scheme has been prepared after detailed engineering and cost of the same including 10 years O&M is Rs 236.30 Crs. Brief of various provisions included in the proposal and adopted design parameters, were informed and it was requested to accord technical sanction to the submitted proposal. agenda item was deliberated in detail. During deliberations, it was confirmed that provisions taken in the proposal are as per sanctioned scheme and are in accordance with the guidelines

/ policies of the department. After deliberations, it was decided to accord technical sanction to the package (including O&M of 10 years) for basic cost of Rs. 236.30 Crs. (Annex.-5/NAI-1/TC 579/ 14.05.2013) subject to following riders:-

- ➤ Reservation/ availability of water in Bisalpur Dam for the requirement of the scheme for its entire design period, shall be ensured before taking up execution of the work of the instant scheme.
- ➤ Availability of the budget shall be ensured before initiating tendering for the work.
- ➤ Provision for surge design from IISC Bangalore/other approved institution and providing surge protection devices accordingly, shall be made part of tender document for the work.
- ➤ Detail drawings and SLD of pumping stations shall be prepared and made part of the tender document.
- ➤ Detailing of proposed SCADA system shall be worked out in consultation with the expert and provisions shall be included in the tender accordingly.
- ➤ Detailed estimates shall be prepared for all lump sum provisions included in the proposal (including O&M) and shall be approved by concerned SE/ACE before tendering.
- ➤ Though design of cluster distribution network has been done with the minimum residual pressure at highest point of MH/OH, however it shall be ensured that a minimum residual pressure of 7 mtr. is maintained at the tail end PSP of the MH/OH.
- ➤ Provision for statutory charges payable to JVVNL, PWD and others shall be limited to the actual estimates from these agencies.
- Acquisition of land and clearance from all the agencies for execution of work shall be ensured timely so that there is no hindrance at the time of execution.
- ➤ List of habitations to be covered under the package with their status as on 01.04.2013 (as indicated in IMIS) shall be provided to CE(R).
