1. A proposal has been received by this office from Sh. Surender Kumar Gaur, Designation SSE, office of the Dy. Chief Engineer, Construction Shivaji Bridge-1, Northern Railway for diversion under FCA,1980 of .286 Ha of forest land for non-forestry purpose. The subject envisages the use of forest land for raising of existing guide bunds of Railway Bridge across river Yamuna in c/w 3-4 lin B/w Anand Vihar-Tilak Bridge.
2. The Site Inspection of the forest land involved in the proposal has been done by me on dated 9/5/2021. During the site inspection of the site, it is found that the land required by the user agency is a forest area measuring .286 Ha.
3. The requirement of the forest land as proposed by the user agency in part 1 of the proposal is unavoidable and is barest minimum required for this project.
