विषय: जनपद देहरादून में प्रधानमंत्री ग्राम सड़क योजना के अन्तर्गत कथियान से डिरनाड मोटर मार्ग के निर्माण (लम्बाई 7.500 कि.मी.) हेतु 3.0835 हे० हेतु वन संरक्षण अधिनियम, 1980 के अन्तर्गत वनभूमि प्रत्यावर्तन का प्रस्ताव।

उपरोक्त विषयक सन्दर्भित पत्र के क्रम में वन संरक्षक यमुना वृत्त महोदय देहरादून के द्वारा दिनांक 15.07.2019 को ई०डी०एस० के माध्यम से लगाई गई आपत्ति का निराकरण निम्न प्रकार है:-

1.	Copy of non encumbrance certificate is not upaloded at para L-iv-h of online part I. Instead, suitably certificate of land selected for CA is uploaded. Non encumbrance certificate should be bearing the declaration that land selected of CA is free of any legal dispute and not occupied by any one, not allotted for any other purpose to anyone or any institution etc.	Required non encumbrance certificate for CA land now uploaded at Para L-iv-h of Part-I online.
2.	In the list of trees uploaded at additional information details of online part I, total 140 trees have been counted only in 6.00 metre width wheareas in other documents contained in hard copy of proposal (prapatra-21, 21.1, and 24) total 314 trees have been mentioned to be felled. Further more, on the obervation of other documents like Certificate of width and lenth of project, Joint inspection report, Bar cart and Prativaden, it has been found that width of road in forest land is 7 metre. But trees counting list uploaded online is of 6 metre width. User agency and DFO provide clarifcation or do the necessary correction in this regard.	The List of trees uploaded at additional information details of online part I, total nos. of 140. Trees are required to be fallen/cut since 'as per PMGSY norms' only 6.00 mtr. wide road is required to be constructed at site accordingly the trees counted in 6 mtr. width only after inspection of DFO Chakrata dated 25.03.2019.
