2. Any type of water of the building shall not come on the road or its Barms and it may assured that no construction shall be done on the property of Public Works Department.
3. The construction of drain for the seepage water may be assured in the path of building.
4. The applicant shall bound to get N.O.C. of the building on the property after its construction and the installation of Sign Board of the building be assured.
5. No violation shall be acted of directions of PUDA Act/Scheduled Roads Act/ I.R.C.
6. The applicant has deposited the inspection fee of Rs. 10,000/- vide draft No. 013793 Dated 27-06-2019 and Rs. 5,000/- vide draft No. 013794 Dated 27-06-2019 as per notification No. 5/13/2018-3BR3/1294287/3 of Punjab Government, Public Works Department B & R Chandigarh.
7. Applicant shall bound to deposit the applicable amount as per notification No. 5/13/2018-3BR3/1294287/3 of Punjab Government, Public Works Department B & R Chandigarh.
8. Applicant shall bound to deposit the fee applicable fee while getting the final N.O.C.
9. No damage shall be caused to the I.O.C. Company Petrol Pump already installed on the said site.
