10 years O&M on SPR basis against NIT no. 01/2017-18 (EC Rs. 280.28 Crs.)

- (ii) Due to earnest effort by the Standing Negotiation Committee, the lowest bidder M/s NCC Ltd., Hyderabad has offered a rebate of Rs. 15.60 Crs. (Rs. 9.60 Crs. and Rs. 6.00 Crs. on capital works and on O&M respectively) with its final offer as Rs. 336,32,15,432/-only.
- (iii) Work of main transmission system of the project has already been completed and instant work is for coverage of 315 villages of Mandalgarh, Bijoliya and Jahajpur Tehsils which are to fed from the already executed transmission system.
- 2. Though the negotiated offer is higher than the estimated cost and assessed cost, however, in view of changed site conditions since original award of work in October, 2013, difficult site conditions, work being against the rescinded work, need of work to utilize the developed transmission system and to provide benefit of drinking water to problematic 315 villages and open tendering process adopted as per RTTP Rule, 2013, the Standing Negotiation Committee considered the negotiated offer of Rs. 336,32,15,432/- for approval.
- 3. The agenda item was deliberated in detail. During deliberations it was emphasized by CE(SP) that work is of urgent nature in order to utilize the developed infrastructure of transmission main for providing water to 315 problematic villages. After deliberations, it was decided to approve the negotiated offer of lowest bidder M/s NCC Ltd., Hyderabad for Rs. 336,32,15,432/as recommended by Standing Negotiation Committee and CE(SP) subject to following:
 - (i) Compliance of all general limitations / conditions and provisions of new SOP dated 08.03.2017 mentioned at note 1 to 9 of item no. 16 shall be ensured before issuance of work order.
 - (ii) No expenditure beyond A&F sanction shall be carried out without prior competent approval.
 - (iii) Required clearances from all the agencies shall be obtained well in time so as to avoid any hindrance during execution of work.
- 4. Conclusion of decision: Approved the negotiated offer.
