
In continuation to the letter under reference (3) above cited, the following report is herewith submitted:-

1. The total cost of the scheme is about 148.94 lakhs for this line. Instead of this amount the total package (cost of Board's Proceedings) including various line and sub station works was wrongly furnished in the proposal. This scheme is to transmit the thermal energy generated by the Neyveli Lignite Corporation to the Kanchipuram district. This scheme is for the overall growth of the area where the line is passing in such a way that to connect the nearby sub stations in future according to the load growth and hence there is no specified employment likely to be generated due to this project.
2. The certificate for Forest Rights Act and non-availability of non-forest lands issued by the District Collector, Kanchipuram is uploaded.
3. Copy of Survey of India topo sheet indicating the alternative routes examined is also uploaded. (Under segment D. i(a))
4. The certificate for completion of process under Forest Rights Act 2006 issued by the District Collector, Kanchipuram is uploaded in the segment K.



5. The earlier proposal furnished for Chettipunniyam RF and Thirutheri RF for diversion of 6.026 Ha RF land is withdrawn.

Under the above circumstances, I kindly request that this proposal may kindly be forwarded to the field officials for further processing so as to avoid further delay in completion of this project please.


**TO WHOM SO EVER IT MAY CONCERN**

In compliance of the Ministry of Environment and Forests (MoEF), Government of India's letter No.11-9/98-FC(pt) dated 3<sup>rd</sup> August 2009 wherein the MoEF issued guidelines on submission of evidences for having initiated and completed the process of settlement of rights under the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 ('FRA' for short) on the forest land proposed to be diverted for non-forest purposes, to be diverted non forest purposes read with MoEF's letter dated 5<sup>th</sup> February 2013 where in MoEF issued certain relaxation in respect of linear projects, it is certified that forest land, identified for the construction of transmission line by the TANTRANSCO line within the jurisdiction of Thirutheri village in Chengalpattu Taluk, Kanchipuram District.

It is further certified that :

- a) There is no alternate vacant/Government land available in Chengalpattu Taluk Thirutheri village Reserve Forest for laying the transmission line from Cuddalore to Veerapuram 230 KV SS.
- b) The proposal has been examined with reference to the ensuring compliance of scheduled Tribes and other traditional Forest Dweller (Recognition of Forest Rights) Act 2006.
- c) There are no Scheduled Tribes and other Traditional forest Dwellers in the forest areas of the Thirutheri village of Chengalpattu taluk, Kanchipuram district and consequently no claim have been received under this Act with respect to the area proposed.
- d) There are no tribal Groups (PTG) and Pre-Agricultural Communities (PAC) in the forest area of Thirutheri village of Chengalpattu taluk, Kanchipuram District, Hence the recognized rights of PTG and PAC are not affected.
